



# QUESTION PRESENTED

Petitioner, Martin Akerman, appearing pro se, respectfully submits this Motion for Extension of Time to Complete Service of Process and Refiled Motion for Injunction. This motion is necessitated by the need for an injunction to prevent further harm to Petitioner while the petition for a writ of certiorari is under consideration by this Honorable Court.

• Whether the denial of a temporary injunction by the Seventh Circuit Court of Appeals, despite evidence of the defendant's actions that jeopardize the applicant's financial stability, violates the applicant's contractual rights and poses an imminent threat of irreparable harm to the applicant's financial and personal well-being.

#### REFILED MOTION FOR INJUNCTION

To the Honorable Amy Coney Barrett, Associate Justice of the Supreme Court of the United States:

Petitioner, Martin Akerman, respectfully moves this Honorable Court for an injunction. In support of this motion, the Petitioner states the following:

# 1. Background

On July 31, 2024, Petitioner filed a petition for a writ of certiorari and a motion for leave to proceed in forma pauperis in the Supreme Court of the United States, relating to the Seventh Circuit Court of Appeals decision in Case No. 24-1245. The original deadline for Respondent, Northwestern Mutual Life Insurance Company, to file a response was September 3, 2024.

Due to issues with service of process, as detailed below, Petitioner was unable to serve Northwestern Mutual by the required deadline.

# 2. Service of Process Issues

On September 1, 2024, Petitioner received notice of undelivered process of service by mail. Petitioner promptly took action to address this issue. A summons was issued on September 4, 2024, in response to Petitioner's request for issuance of summons, submitted on September 3, 2024. Due to the delay in processing and failed service, Northwestern Mutual did not receive the necessary documents needed to file a timely response.

To prevent future issues with service of process, Petitioner arranged for a local Wisconsin process server to serve Northwestern Mutual Life Insurance Company. Service was effected on September 13, 2024, Attachment C.

#### 3. Injunction Request

Petitioner respectfully requests this Honorable Court to grant an injunction against Northwestern Mutual Life Insurance Company, halting any adverse actions, enforcement of judgments, or collection activities related to the ongoing dispute between the parties, pending the final resolution of this case.

Petitioner asserts that an injunction is necessary to prevent irreparable harm, protect his rights, and maintain the status quo while this Court considers the petition for a writ of certiorari. Without an injunction in place, Petitioner's financial livelihood and rights under the applicable laws would be severely harmed.

As directed in the Supreme Court Clerk's letter, dated August 1, 2024 (attached hereto as Attachment B), Petitioner was instructed to file a new, explicit request for an injunction. Petitioner complies with that instruction by refiling this motion and reiterating the necessity of injunctive relief in this matter.

Given the complexities of this case and its implications,

Petitioner believes that equitable relief is appropriate to

ensure a fair and just outcome.

# 5. Conclusion

Petitioner has acted diligently to comply with the rules of this Court and respectfully submits that the granting of an injunction is necessary to ensure the just and efficient resolution of this case. Petitioner requests that the Court grant the relief sought in this motion.
