MOTION FOR EXTENSION FOR WRIT

OF CERTIORARI SUBMISSION

As instructed by the clerks at the SCOTUS that I need to ask for more time to finish my Writ Of Certiorari. I had been given an outdated version of the rule book from july of 2019 and also hadn't understood or been told that I needed to transcribe all video evidence in order to essentially submit the videos in writing as they aren't accepted in any other way which will take a substantial amount of time given the number of videos. I've also been suffering from severe panic attacks during every attempt to make progress with these documents greatly slowing said progress. I would respectfully ask for an additional 60 days on top of the 90 days from the time of the decision from the SJC here in Massachusetts. The original decision was given to me on September 6 2024. The email from the SJC will be included as instructed by the clerks so you may see the original date. I'd like for an additional 60 days which would be February 3 2025. I believe given my disabilities and the abuse suffered at the hands of the Chicopee Housing Authority causing PTSD and severe panic attacks, this should be a reasonable accommodation. I also lost a substantial amount of time to work on this or the FAR application issues while they held my computer hostage for a month after illegally evicting me without warning or notice during the deliberations at the SJC and without Judge Kane being given the rescript from the appeals court which was not sent due to it being escalated into a FAR application which he was made aware of and had not been decided upon and rejected until September 6 2024, while Judge Kane knew about the FAR application being processed and wrongfully evicted me on June 4 2024, ignoring due process and intentionally harming me by abusing his position. This preventing any sort of work while I did not have access to my computer during that time either,

cutting into my initial 90 days to start on this and submit it. There was also damage to the hard drives, hard drive docks and internal components which required repair. I was told to make sure this was addressed to Justice Jackson to ensure it was received and processed in a timely manner as it was only her that handled extension requests but to not say her name on the envelope which I will not, that will addressed to the Clerks.

That's why all communications to me were later only accepted or allowed through the E-file system and could be confirmed, and tracked both by me and the courts so no more documents went "missing" or were undelivered and I was not notified because of it. I ask all filings from them be submitted by Certified mail as well to the address listed on here.
