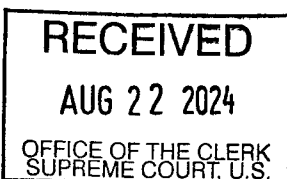

Dear, U.S. Supreme Court Chief Justice——

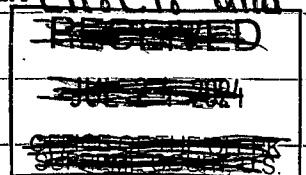
Be advised... Because the Enclosed petition for Writ Of

Supreme Court rejected it. So, I'm now asking for you to direct
the Clerk to file my late petition.

U.S. Chief Justice I, Reginald Dunahue need you to grant me a ~~XXXXXX~~
a leave to Submit My meritorious, but late petition for Writ Of Certiorari.
Chief Justice, East Arkansas Prison Unit Warden Jackson and his
Staff habitually prevents me to timely mail out any paper work to the
Courts by withholding envelopes from me.. Chief Justice, I've rec-
urrently and formally complained about it but to no avail.

Chief Justice, its hard for me to timely mail out any paper work to
the U.S. Supreme Court because East Arkansas Prison Unit's warden

denied on March 14, 2024. If prison officials block my access to Chief Justices, Court Clerks and Court judges... Extraordinary Circumstances for me to receive a Court's ~~XXXXX~~ leave to Submit a belated petition for Writ Of Certiorari, exists.

Chief Justice, I've enclosed grievances vouching that I'm going through problem receiving envelopes. Each grievance enclosed got rejected because the people I accused denied guilt. Those people block my access to the Courts! So, I'm not at fault for coming late with my petition.

Conclusion
