

**What does it mean to have a **positive** test result?**

If you have a positive test result, it is likely you have COVID-19. Therefore, it is also likely that you may be placed in isolation to avoid spreading the virus to others. There is a very small chance that this test can give a positive result that is wrong (a false positive result). Most cases can be cared for at home. Stay home and limit contact with other until:

You have been fever-free for at least 3 days without using medicine that reduces fever **AND** your symptoms have improved **AND** at least 10 days have passed since your symptoms first appeared.

- Do not go to the hospital to seek care unless you have a medical emergency
- Do not go to work, notify your employer of your positive test result
- Contact your primary care provider and inform them of your positive COVID-19 test result
- Continue to monitor your symptoms at home and seek medical attention if symptoms worsen
