

## MOTION FOR EXTENSION OF TIME TO FILE PETITION FOR WRIT OF CERTIORARI

To the Honorable Chief Justice and the Associate Justices of the Supreme Court of the United States:

Applicant, RAMESH KAPUR, proceeding pro se, respectfully moves this Honorable Court for an extension of sixty (60) days, from July 3, 2025, to September 1, 2025, within which to file a Petition for a Writ of Certiorari to review the judgment of the Supreme Court of Texas in the above-captioned case.

This corrected application follows the return of Petitioner's timely filed request, and is submitted pursuant to **Rule 13.5** of the Rules of the Supreme Court of the United States. The Court has jurisdiction under **28 U.S.C. § 1257(a)** to review the final judgment of the highest court of a state in which a decision could be had.

#### 1. Judgment Sought to Be Reviewed

The judgment sought to be reviewed is the **denial of rehearing of the petition for review** by the **Supreme Court of Texas**, in Case No. 24-0622, entered on **April 4, 2025**. A copy of this order is attached as **Appendix A**.

## 2. Procedural History and Prior Filing Attempt

a. On **April 4, 2025**, the Supreme Court of Texas denied Petitioner's motion for rehearing of the petition for review.

- b. Under **Rule 13.1**, the deadline to file a petition for writ of certiorari was **July 3, 2025** (90 days from the date of the denial).
- c. On **July 3, 2025**, Petitioner timely filed an **Application for Extension of Time** by mail, with the package postmarked that same day, thus satisfying the Court's timeliness requirement.
- d. On July 9, 2025, the Clerk of this Court returned the filing due to the inadvertent omission of a copy of the state court's denial of rehearing.
- e. Petitioner received the returned filing on **July 19, 2025**, and promptly contacted the Clerk's Office. Upon receiving guidance, Petitioner prepared and now submits this corrected application with the required attachment.

## 3. Grounds for Extension: Medical Emergency and Good Cause

- a. Petitioner respectfully submits that **good cause** exists for this request. The underlying case raises **substantial federal questions**, including whether a property owner may be deprived of notice of a critical hearing when both the court and opposing counsel had been provided an updated address at a prior court-ordered hearing. The matter implicates **due process rights** protected under the Constitution.
- b. In addition, Petitioner was unexpectedly hospitalized for urgent surgery on June 17, 2025, at Baylor Hospital, for the removal of a colon mass. The procedure, performed under general anesthesia, was medically necessary due to a high risk of cancer, compounded by Petitioner's pre-existing coronary artery disease.

c. Post-operative complications required readmission to the emergency room on June 18, 2025, and Petitioner's attending surgeon prescribed strict rest and recuperation

through **July 4, 2025**.

d. These health circumstances severely impaired Petitioner's ability to complete legal

work and caused unavoidable delay. Petitioner was physically and mentally unable to

focus on the complex legal issues and voluminous record necessary for the Petition for

Certiorari.

e. This corrected application is filed in good faith, without intent to delay, and promptly

upon Petitioner's recovery and discovery of the procedural deficiency.

WHEREFORE, Petitioner respectfully requests that the Court grant an extension of sixty (60)

days, from July 3, 2025, to September 1, 2025, within which to file the Petition for a Writ of

Certiorari.
