**RE: No. 17-1165, *David L. de Csepel, et al. v. Republic of Hungary, et al.***

Dear Mr. Harris:

I represent Respondents in the above-captioned matter. The petition for a writ of certiorari in this case was filed on February 16, 2018, and placed on the docket on February 21, 2018. On February 28, 2018, this Court granted Respondents' unopposed request to extend the deadline within which to file a brief in opposition from March 23, 2018 to April 23, 2018.

Respondents respectfully request, under Rule 30.4 of the Rules of this Court, a second extension of time to and including May 21, 2018, within which to file a brief in opposition.

The extension is necessary because the attorneys with principal responsibility for the preparation of the brief in opposition are heavily engaged with the press of other matters, including the forthcoming reply in support of the petition for a writ of certiorari filed with this Court in *Thyssen-Bornemisza Collection Foundation v. Cassirer, et al.*, No. 17-1245, docketed on March 7, 2018. The respondents there filed a brief in opposition on April 6, 2018. On the same day, a prospective *amicus curiae* filed a motion for leave to file and submitted a proposed brief *amicus curiae* in support of the respondents. The petitioner's reply to both briefs in that case is due no later than April 20, 2018, the Friday before the brief in opposition in this action is currently due to this Court.

Further, Petitioners will not be prejudiced, as the requested extension will not interfere with this action as it proceeds in the district court. *See de Csepel v. Republic of Hungary, et al.*, No. 10-cv-1261(ESH). Respondents' reply in support of their motion to dismiss in district court is due April 23, 2018, the same day the brief in opposition is currently due to this Court.

I have conferred with Counsel of Record for the Petitioners, who consents to this extension.
