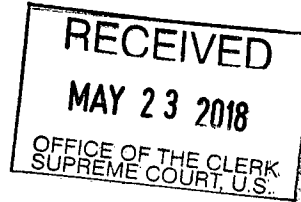

Dear Mr. Harris:

I represent petitioner in the above-captioned matter, which is currently pending before this Court on a petition for a writ of certiorari. Consistent with this Court's Rule 12.6, I write to notify you that petitioner is no longer pursuing any relief against respondents Northwest Trustee Services, Inc., and RCO Legal, P.S., in this case. The petition thus remains pending solely against respondent Green Tree Servicing LLC, and the other respondents no longer have any interest in the outcome of the petition.

The petition was filed in this case on March 26, 2018, and placed on the Court's docket on March 27, 2018. On the following day, respondents Northwest Trustee Services and RCO Legal were placed into a state-law general receivership, activating an automatic stay under Washington state law. See *In re Receivership of Nw. Tr. Servs., Inc. & RCO Legal, P.S.*, No. 18-2-08146-7 (Wash. Sup. Ct. Mar. 28, 2018). In light of this development, petitioner is no longer seeking review of the judgment below with respect to those two entities, and their victories below are thus preserved. The petition remains pending solely against respondent Green Tree Servicing LLC.

Petitioner has communicated with all respondents about the substance of this letter, and no respondent has raised any objection.
