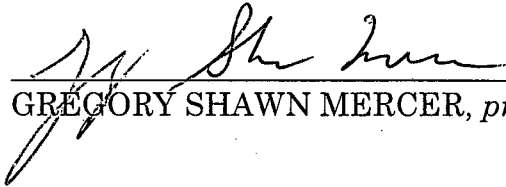
I hereby certify that on this 22nd day of December, 2017, I have filed 40 copies of a Rules 15.8 & 33.1 Amended Supplemental Brief of Petitioner. This is supplemental to my 12/18/2017 Rule 33.1 Paid Petition for Writ of Certiorari to the Supreme Court of Virginia. The Amended Supplemental Brief of Petitioner complies with the word limitations (Rule 33.1(h)) and has 1,569 words.

On 9/21/2017, this Court Docketed the In Forma Pauperis version of my 12/18/2017 Petition for Writ of Certiorari. On 10/6/2017, the Supreme Court of Virginia made a Final Judgment in Record No. 170569. On 10/30/2017, this Court denied me the privilege of proceeding in Forma Pauperis which led to my re-filing after two time extensions (11/2/2017 & 11/29/2017) of a Rule 33.1 Paid Petition for Writ of Certiorari with a Rule 33.1 Appendix on 12/18/2017. On 11/2/2017, the Fairfax County Circuit Court made what would become on 11/28/2017 & 11/29/2017 Final Judgments in Case Nos. MI-2017-1481 & MI-2017-1482.

Since 9/21/2017, there have been Intervening Cases listed above and this 12/22/2017 Amended Supplemental Brief of Petitioner is Intervening in the sense that these new cases were to be excluded from the 12/18/2017 Petition for Writ of Certiorari having a Rule 33.1 Appendix that had to be adjusted slightly (the new Rule 33.1 Appendix would have needed photographs of three Exhibits which situation Petitioner did not find addressed in

Rule 33.1 so his new Rule 33.1 Appendix has Photograph Explanations he felt at liberty to make).

So in accordance to Rule 15.8, these Intervening Matters warrant a Supplemental Brief. Since I already filed a 10/12/2017 Supplemental Brief of Petitioner which is now **MOOT**, this 12/22/2017 "Amended" Supplemental Brief of Petitioner differentiates itself from my 10/12/2017 Filing with the word "Amended."
