Re: Terance Martez Gamble v. United States, No. 17-646

Dear Mr. Harris:

The government writes to correct its description of the interaction between petitioner's federal sentence in the above-captioned case and the state sentences he was serving when that federal sentence was imposed. See Gov't Br. 5-6, 55. The district court sentenced petitioner to 46 months of imprisonment, directing that petitioner's federal sentence "run concurrently" with his concurrent 12-month state prison terms and that petitioner "shall receive credit for time served as calculated by the [Bureau of Prisons (BOP)]." J.A. 31. So far as we are aware, the court did not itself adjust the federal sentence to account for approximately five months of state imprisonment that preceded the federal sentencing, as the Sentencing Guidelines recommend in cases where a defendant is serving a sentence for relevant conduct that will not result in a BOP credit. See Sentencing Guidelines § 5G1.3(b) (2015). Because the BOP ultimately determined that petitioner was not entitled to credit for that five-month period, the total possible length of petitioner's incarceration for his state and federal offenses was 51 months. Based on federal good-time credits, however, he is currently scheduled to be released after a total of 45 months of state and federal incarceration. See 18 U.S.C. 3624(b).
