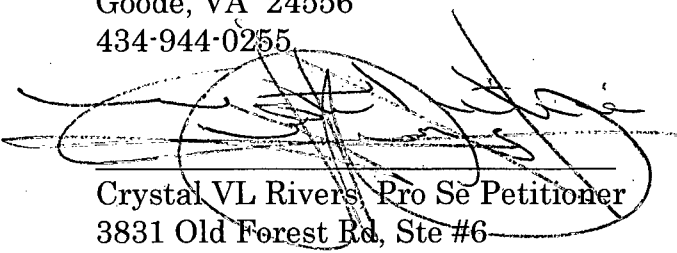

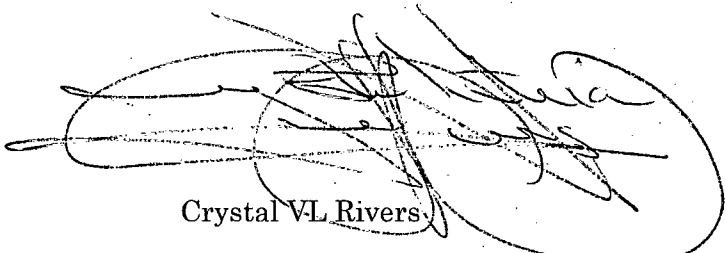
AFFIDAVIT
