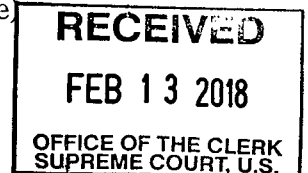

9) Do you expect any major changes to your monthly income or expenses or in your assets or liabilities during the next 12 months?

First off I expect to beat my current charges and be freed. Upon being freed, shortly there after I plan to have some sort of job. At that point I will also have more expenses. I will have to help my mother pay the mortgage of the home I own. She currently lives there and pays all bills. My Student loan is paid up until Jan. of 2019, because for years I paid much more than the monthly requirement. But, I have not been able to pay on it for $3\frac{1}{2}$ years and a \$280.00 monthly payment will be due in January of 2019.
