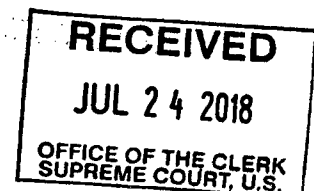

COMES NOW THE PETITIONER AND FOR HIS CAUSE STATES:

1. THE PETITIONER HAS FILED THE CASE 17-8084.
2. THE PETITIONER HAS REQUESTED TIME TO FILE IN THAT THE SUPREME COURT HAS DENIED THE MOTION TO FILE IN FORMA PAUPERIS.
3. THE DECISION OF THE COURT TO DENY THE FILING IN FORMA PAUPERIS WAS MADE JUNE 25, 2018.
4. TH DECISION FOR EXTENTION FOR TIME TO FILE WAS MADE PREVIOUS TO THE DETERMINATION OF THE COURT TO DENY FILING IN FORMA PAUPERIS.

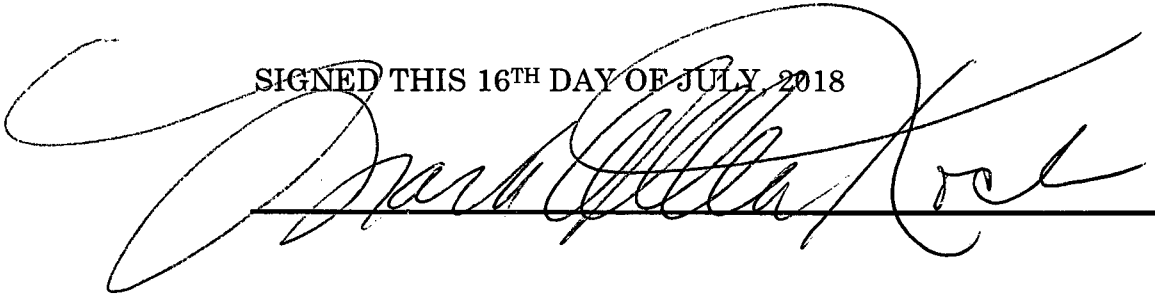

THE PETITIONER DOES BELIEVE THAT THE CASE HAS SUFFICIENT BEARING UPON BOTH FEDERAL AND STATE OPEN MEETINGS ACTS WITH FOUR ITEMS VOTED ON IN AN OPEN MEETING OF THE PUBLIC BODY THAT WERE NOT ON THE AGENDA OF THE PUBLIC BODY, ALL DISCUSSION FOR APPOINTMENT OF THE CITY ADMINISTRATOR WAS MADE IN EXECUTIVE SESSION 14 DAYS AFTER THE FIRING OF THE PREVIOUS CITY ADMINISTRATOR, THE PETITIONER WAS ORDERED TO SHUT OFF THE RECORDER DURING REGULAR SESSION OF THE PUBLIC BODY, AND THE RIGHT TO RECORD WAS OBLITERATED AFTER THE EXECUTIVE SESSION.
