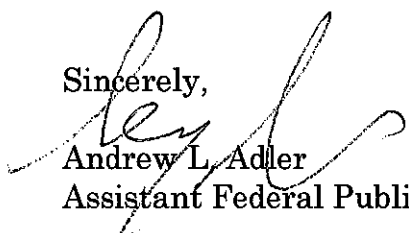
Dear Mr. Harris:

The above-captioned case has been distributed for the Court's consideration at its Conference of September 24, 2018. Petitioner respectfully requests that the Court reschedule this case in light of the pending petition in *Audy Perez v. United States*, No. 18-5217, which will be distributed this week for the Court's conference of October 5, 2018.

Today, the petitioner in *Perez* submitted a reply in support of a petition presenting the same question here. As that reply explains, that case presents the ideal vehicle to decide the question presented. Notably, the government does not identify any potential vehicle problem with *Perez*, even though it has done so here and in every other related petition to which it has responded. Accordingly, Petitioner respectfully requests that the Court reschedule this petition so that it may be considered at the same time as *Perez* and ultimately held if that petition is granted.
