The court has read and considered the record, the case history and the pleadings of Defendant Raa.

The court finds no error in denying the Code of Civil Procedure Section 170.6 peremptory challenge as to Judge Peterson on August 13, 2015. Defendant is permitted one peremptory challenge per case which was exercised against Commissioner Anderson on May 15, 2015.

Defendant's subpoena, discovery requests, and Pitchess motion were all improper and defective. There was no error in failing to comply with the improper requests.
