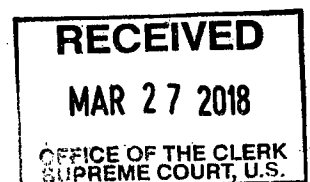

- 1) Petitioner, Joseph Booker, is currently confined at Menard Correctional Center in Menard, Illinois;

- 3) The Petitioner receives a \$10 "statepay" from the Illinois Department of Corrections for indigency aid, monthly; totaling to \$120 annually;
- 4) Petitioner is without the finance or any assets, and et cetera to cover the cost of litigation in this matter;
- 5) Petitioner attaches a Declaration of Indigency in support of this instant motion to proceed in forma pauperis;
- 6) Because of Petitioner's financial state, and inability to pay the cost of litigation in this matter, Petitioner respectfully request that this Honorable Court allow him to proceed in forma pauperis.
