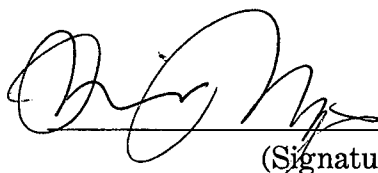

The \$166.67/mo. (Question 1) and \$1144.37 (Question 4) represented a one time payment in relation to the settlement of a lawsuit. Before this settlement (after the filing of appeal) Petitioner was extremely indigent and will be again once these funds are exhausted. Previously, Petitioner depended upon donations of >10/mo. from his elderly mother on fixed-income. The above funds represent the only money he has for food, hygiene, legal/writing supplies, and postage for the duration of a life sent.
