I. Question(s) Presented

(1) Pursuant to U.S. Constitution Article VI, Paragraph 2... and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding. Mean that the Judges who Filed their Judgment on June 30, 2014; Order on January 26, 2016; and Order on February 1, 2018, are bound by their Oath or Affirmation to uphold U.S. Constitution Article IV, Section 1: "Full Faith and Credit shall be given in each State to the public Acts, Records, and judicial Proceedings of every other State"?

(a) Are the Judges of the U.S. district court(s), and U.S. Court of Appeals 9th Circuit, operating under U.S. Constitution Article 1, §8, clause 17-18?

3 (3) On July 17, 2013, Cynthia Imbrogno, d.b.a. U.S. Magistrate Judge, initiated a Malicious Prosecution, that
4 lacked Jurisdiction and Probable Cause, against Allah's® Debtor COSTON, EDWIN RANDALL. See
5 Initial Appearance: 7-17-13; Certified Debtor Information Search Report;

7 (4) On March 25, 2014, Allah® entered the Name Change Judgment, and Order into the Record in Bogus
8 Case No. CR-13-112-AH. See Sealed Transcript, June 26, 2014.

9

10 (5) On June 30, 2014, Ancerhi Haggerty, d.b.a. U.S. district court Senior Judge, Sealed the
11 Sentencing Transcript, and issued a Judgment on Allah's® Debtor COSTON, EDWIN RANDALL. See
12 Judgment, June 30, 2014.

13

14 (6) Allah® Appealed to the C.D.A. 9th Cir., Case No. 14-30129, and the Court unsealed the Sentencing
15 Transcript, dismissed the Appeal, issued their Order in violation of U.S. Constitution Article IV, Section
16 1. See Order, January 26, 2016.

17

18 (7) Allah® Filed a Judicial Misconduct, and the Judicial Council of the 9th Circuit ruled in violation
19 of U.S. Constitution Article IV, Section I, with knowledge that the King County Case No. 02-1-0057-
20 6 SEA, is invalid. See Order, February 1, 2018; Letter dated October 31, 2017, with legal
21 Notice And Demand.

23 IV. Grounds For Issuing Writ

24

25 It may be issued by any court, except a district or municipal court, to any inferior tribunal, corporation,

1 board or person, to compel the performance of an act which the law especially enjoins as a duty resulting
2 From an office, trust or station, or to compel the Admission of a party to the use and enjoyment of
3 a right or office to which the party is entitled, and From which the party is unlawfully precluded by
4 such inferior tribunal, corporation, board or person.

5
6 Requirements. To warrant the writ of mandamus, there must be a clear legal right to have a
7 decision in respect to the thing sought. U.S. Constitution Article IV, Section 1.

8
9 Use. Mandamus is sought to compel action not to review it...

10
11 Judgments. Mandamus allowed as a remedy for enforcement of a Judgment. Judgment
12 Changing Edwin R. Coston, to Divine Answer Born Supreme Allah, Entered January 31, 1995; Order
13 Changing Name From Divine Answer Born Supreme Allah, to Allah, Ordered, Adjudged and Decreed,
14 November 1, 1999.

15
16 In general. Mandamus may lie to compel court to act in a particular way when Facts are not
17 disputed and court has come to a wrong conclusion of law therefrom, or disregarded a duty
18 expressly enjoined by law. U.S. Constitution Article VI, Section 2; U.S. Constitution Article
19 IV, Section 1.

20
21 Mandatories. Mandamus will issue against an officer of the United States to compel the performance
22 of a duty imposed by law as resulting from or pertaining to his office. U.S. Constitution
23 Article VI, Section 2. 28 U.S.C.

24
25 Absence of remedy at law required. The writ must be issued in all cases where there is not a

1 plain, speedy and adequate remedy in the ordinary course of law. See, Other Orders/Judgments CR-13-112-
2 ALH/TOR.

4 V. Petition For a Writ of Mandamus

6 Comes Now Allah[®], Aggrieved Party, under Oath, petitions this United States Supreme Court, pursuant to
7 Supreme Court Rule 20. 3. (a), For the issuance of a Writ of Mandamus directed to Ancer L. Haggerty,
8 d.b.a. U.S. District Court Senior Judge For Eastern District Spokane, and Silverman, Rybee, Watford, Conby,
9 M. Smith, N.B. Smith, Murguia, Moskowitz, Phillips, Seabright, Aiken and Mollway, d.b.a.
10 U.S. Court of Appeals 9th Circuit Judges, to compel the performance of a duty imposed by law as
11 resulting from or pertaining to their office. U.S. Constitution Article IV, Section 1, U.S. Constitution
12 Article VI, Section 2. To then and there on the 29th, day of February, 2018, explain
13 the authority and legality under which Allah[®] is being restrained, and if no legal authority then
14 be shown, to immediately release and discharge Allah[®] from such restraint, with compensation,
15 \$250,000.00 in a Certified Check, written out to Allah[®], with \$50,000.00 in Travelers Checks,
16 and \$5,000.00 in cash.

18 In support of this petition, Allah[®] states that Allah[®] is being illegally/falsely imprisoned by
19 Donald B. Holbrook, Superintendent of Washington State Penitentiary, 1313 N. 13th Avenue, IMU-
20 South G-08, Walla Walla, WA 99362.

22 The restraint is illegal/false because the documents issued from the King County Superior Court
23 Clerk are invalid, the Correspondence Document Tracking Slip For Case No(s) 01-1-0907-3 SEA;
24 01-1-09176-6 SEA; 02-1-02047-6 SEA (missing) are telling you that the Judgment And Sentence are
25 Reject. Furthermore there are no Warrant of Commitments, or Jail Certifications Filed with

11 Bybee, Watford, Canby, M. Smith, N.R. Smith, Murguia, Moskowitz, Phillips, Seabright, Aiken and
12 Molloway, d.b.a. U.S. Court of Appeals 9th Circuit Judges, to compel the performance of a duty imposed
13 by law as resulting from or pertaining to their office, U.S. Constitution Article IV, Section 7, U.S.
14 Constitution Article VI, Section 2. To then and there on the 28th day of February, 2018,
15 explain the authority and legality under which Allah[®] is being restrained, and if no legal authority then
16 be shown, to Immediately Release and discharge Allah[®] From such restraint, with Compensation,
17 \$250,000.00 in a Certified Check, written out to Allah[®], with \$50,000.00 in Travelers Checks, and
18 \$5,000.00 Cash.

20 Allah[®] affirms under Oath that this Petition For a Writ of Mandamus is the Truth, the whole Truth,
21 and nothing but the Truth, on the Undersigned's Unlimited Commercial liability, True, Correct, Complete, not
22 Misleading.
