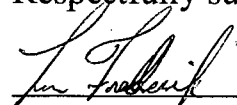
The affidavit of Mr. Frederick in support of this motion is attached hereto. Mr. Frederick did not seek leave to proceed in forma pauperis in the court below.

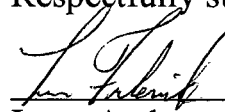

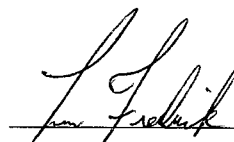
