Dear Mr. Harris:

I represent the respondent, Ron Davis, in the above-entitled case. The petition for a writ of certiorari was filed on May 25, 2018, following a fifty-nine-day extension of time. I have previously received two extensions of time, totaling sixty-two days, to file the brief in opposition, which is currently due on September 5, 2018. Pursuant to Rule 30.4, I respectfully request that the time for filing that brief be extended by another thirty days, to October 5, 2018. Absent unforeseen circumstances, I do not anticipate needing any time beyond October 5, 2018, to file the brief in opposition.

I have now completed a draft brief in opposition. As detailed in my previous request for an extension of time, however, the draft took longer than I anticipated because it involves several issues with which I was unfamiliar, as they were not certified for appeal below until after oral argument, and they were not briefed by the State. I still must allow time for internal review and revision of the draft, in consultation with my supervisors, including the California Solicitor General's Office. Based on my initial consultation with my supervisors, I believe that the process of review and revision, as well as preparation for filing, will take substantially longer than would be permitted by the current deadline.

On August 24, 2018, I communicated with Jonathan Aminoff, counsel for petitioner, who advised me that he does not oppose this request.

Accordingly, I respectfully request that the due date for the brief in opposition to the petition for a writ of certiorari be extended to October 5, 2018.
