Dear Mr. Harris:

On behalf of Respondent-Intervenor Aimee Stephens, I write to request a 30-day extension of time within which to file Respondent-Intervenor's brief in opposition to the petition for writ of certiorari from August 23, 2018 to September 24, 2018.

Counsel for Respondent-Intervenor Aimee Stephens faces significant competing professional obligations. Counsel recently completed cross-summary judgment briefing and is in the process of completing fact and expert discovery, as well as preparations for an October 9, 2018 jury trial date, in *Boyd v. Conlin*, No. 17-cv-264-wmc (W.D. Wis.). Counsel is also engaged in discovery in *Monroe v. Rauner*, No. 18-cv-156-DRH-DGW (S.D. Ill.) and *Vroegh v. Iowa Dept. of Corr.*, No. LACL138797 (Iowa), and is preparing for an evidentiary hearing on August 28, 2018 in *M.S. & A.E. ex rel. P.S. v. Suburban Sch. Dist.*, ALS No. 16-0003 (Ill. Hum Rts. Comm.). Counsel also filed a response to a motion to dismiss on July 27, 2018 and is engaged in discovery in *Ray v. Himes*, No. 2:18-cv-00272-MHW-CMV (S.D. Ohio). Additionally, counsel will be drafting a response brief in *Good v. Iowa Dept. of Hum. Serv.*, No. 18-1158 (Iowa), under an expedited briefing schedule that will require our brief to be filed on a date soon to be set by the Iowa Supreme Court between approximately September 5 and September 11.

These and other previously scheduled engagements and personal and professional commitments during the initial 30-day response period would make it difficult for counsel to prepare the response in this case.
