We represent the Petitioners in the above referenced case. We are writing in regard to a letter dated May 29, 2019, delivered to the Court by Respondent Capitol Records. In material part, that letter informed the Court that on May 24, 2019, an order was entered by the United States Bankruptcy Court for the Southern District of Florida, upon motion by Capitol Records, converting the pending ReDigi, Inc. chapter 11 bankruptcy case to a case under chapter 7.

The chapter 7 trustee who has been appointed in the ReDigi bankruptcy case, Ms. Deborah Menotte, has requested that we provide for the Court's information a letter from counsel, Mr. Michael R. Bakst, Esq., affirming that the trustee does wish that the pending Petition for Certiorari go forward, and that the conversion to chapter 7 has no impact on this Court's consideration of that Petition. ReDigi, Inc. filed a voluntary Chapter 11 bankruptcy petition on August 3, 2016. The case converted to a Chapter 7 on May 24, 2019 and Deborah C. Menotte was appointed as the Chapter 7 Bankruptcy Trustee on May 28, 2019. Ms. Menotte filed an application to employ my firm to represent her with the bankruptcy court on June 11, 2019. A hearing on the application is set for July 2, 2019 and the application is currently pending. On June 7, 2019, the Debtor filed its Motion for Reconsideration of Order Converting Case to Chapter 7 which is also scheduled for hearing on July 2, 2019.

The purpose of this letter is to inform the Court that the Trustee does wish to continue pursuing the petition for a writ of certiorari on behalf of the estate. The conversion of this case to a Chapter 7 proceeding should have no impact upon the proceedings before the Court.
