## DESCRIPTIONS OF AMICI CURIAE

American Friends Service Committee ("AFSC") is a faith-based. human rights organization that promotes lasting peace with justice and transforming social relations in the prison system. Fast Law Publishing Associates ("FLPA") makes books, articles, and pamphlets on a variety of legal and public interest subject, and provides a platform to advocate for legislative change to the criminal justice system. Publishing books like Winning Habeas Corpus and Post Conviction Relief and Post conviction Relief for Washington State: the Personal Restraint Petition, FLPA connects to its subscribing prisoners through Prison Legal News.

Inmate Magazine Service is a magazine subscription services that reaches prisoners seeking access to a variety of printed publications.
