INTEREST OF *AMICUS CURIAE*

The R Street Institute¹ is a nonprofit, nonpartisan public-policy research organization. R Street's mission is to engage in policy research and educational outreach that promotes free markets as well as limited yet effective government, including properly calibrated legal and regulatory frameworks that support economic growth and individual liberty.

ARGUMENT

Certiorari should be granted for the reasons given in the Brief of *Amicus Curiae* the R Street Institute, filed concurrently in *CJ CheilJedang Corp. v. International Trade Commission*, No. 19-1062, which is concurrently on petition for a writ of certiorari before this Court. The present two cases raise substantially the same question presented as *CJ CheilJedang* and are equally appropriate vehicles for raising that question.

To avoid burdening this Court with a duplicative filing, the content of that brief is not repeated here. *Amicus curiae* respectfully requests consideration of the arguments presented in the *CJ CheilJedang* brief, with respect to these two petitions for writs of certiorari.
