Dear Mr. Harris:

I am counsel for Respondents Ajinomoto Co., Inc. and Ajinomoto Animal Nutrition North America, Inc. ("Ajinomoto") in the above-captioned matter. Pursuant to Rule 30.4 and this Court's Orders of March 19, 2020 and April 15, 2020, regarding to extensions pertaining to COVID-19, I am writing to request a 14-day extension of time to file Ajinomoto's brief in opposition to certiorari.

The petition for certiorari was docketed on February 26, 2020. Ajinomoto was previously granted a 30-day extension such that Ajinomoto's opposition is currently due on April 27, 2020. If this requested 14-day extension is granted, Ajinomoto's opposition will be due on May 11, 2020. Counsel for Petitioners CJ CheilJedang Corp., CJ America, Inc., PT. CheilJedang Indonesia, and for Respondent International Trade Commission, have consented to this request for extension of time and electronic service.

Ajinomoto respectfully requests this extension of time due to difficulties relating to COVID-19, which have presented unforeseen complications for this and other pressing matters being handled by the attorneys on this case. In addition to the above-referenced petition, the communications and logistical difficulties associated with the pandemic are complicating several ongoing district court actions, proceedings in the U.S. Patent and Trademark Office, and appeals to the U.S. Court of Appeals to the Federal Circuit. I believe the requested extension of time is reasonable under the circumstances and will ensure sufficient time to fully analyze and respond to arguments raised in the petition for certiorari in this case.
