Pursuant to Supreme Court Rules 15.3 and 30.4, the Respondents, Conservation Commission of Falmouth and Town of Falmouth, respectfully request a 30-day extension of time to file their response to the petition for a writ of certiorari submitted by Janice Smyth. The current due date for the Respondents' brief in opposition is September 19, 2019. Granting this request would extend the deadline for the Respondents' opposition to the petition for writ of certiorari to Monday, October 21, 2019.
