

Counsel for Petitioner Citi Hedge Fund Services Ltd. (“Citi Hedge”) and Counsel for Respondent Irving H. Picard write jointly to inform you that, following Respondent’s settlement with Kingate Global Fund, Ltd. and Kingate Euro Fund, Ltd. in the action *Picard v. Kingate Global Fund, Ltd., et al.*, Adv. Pro. No. 09-1161 (Bankr. S.D.N.Y.) (the “Kingate Proceeding”), Petitioner Citi Hedge is no longer a participant in the above-referenced petition for certiorari filed on August 29, 2019 (No. 19-277). Pursuant to the settlement agreement entered in the
