
Dear Mr. Harris:

I am writing to request a thirty-day enlargement of the deadline by which Respondents must respond to the Petitioner's Petition for Writ of Certiorari. Respondent Associated Faculties of the University of Maine joins in this request. Respondents University of Maine at Machias, and the Board of Trustees of the University of Maine do not object to this request.

The State of Maine (as well as the other Respondents) initially waived their right to respond to the Petition. On February 27, 2020, the Court requested a response to the Petition by March 30, 2020. Due to the press of other business, undersigned counsel anticipates that she will need additional time to prepare a response to the Petition. Accordingly, the State of Maine respectfully requests that the deadline for all Respondents to respond to the Petition be enlarged until April 30, 2020.
