Dear Mr. Harris:

I write pursuant to Supreme Court Rule 30.4, as counsel for Respondents Pennsylvania State Education Association, National Education Association, and Chestnut Ridge Education Association in the above-captioned matter, to request a seven-day extension of time for all respondents to the pending Petition for Certiorari to file Briefs in Opposition. The Petition was docketed on April 2, 2021, and Briefs in Opposition are currently due on May 3, 2021. The requested extension of time would extend the due date for all respondents to May 10, 2021.
