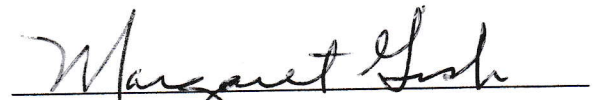

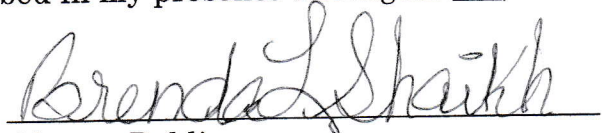
Now comes Margaret Gish, and being first duly sworn on oath, deposes and states as follows based on her own personal knowledge:
