**RE: *Maggy Hurchalla v. Lake Point Phase I, LLC, et al., No. 20-332***  
**Unopposed Motion to Extend Time to Respond to Petition for Writ of Certiorari**

Pursuant to Supreme Court Rule 30.4, Respondents Lake Point Phase I, LLC, and Lake Point Phase II, LLC, respectfully move for an extension of time to file their response to Appellant, Maggy Hurchalla's Petition for Writ of Certiorari in *Hurchalla v. Lake Point Phase I, LLC, et al.*, Docket No. 20-332, for an additional thirty days, until November 13, 2020.

*Counsel for Ms. Hurchalla does not object to the requested relief.*

The Florida Supreme Court denied Ms. Hurchalla's petition on April 13, 2020. Due to this Court's March 19, 2020 Covid-19 Order, the deadline for Ms. Hurchalla to file her petition to this Court was extended. On September 10, 2020, Ms. Hurchalla filed her petition, which was docketed by this Court on September 14, 2020.

Ms. Hurchalla's petition raises several factual claims that require counsel for Lake Point to fully review the underlying trial transcript and record to prepare Lake Point's response. Further, although not discussed in Ms. Hurchalla's petition, there are preservation issues that Lake Point must raise in its response.

Due to the above, and the schedules of Lake Point's counsel, including the due date of other briefs in mid-October, and previously scheduled hearings and arguments in early October, Lake Point respectfully requests an extension of time to file its response to Ms. Hurchalla's Petition for Writ of Certiorari until November 13, 2020.
