Dear Mr. Harris:

I am counsel of record for petitioner in the above-captioned case, which is currently pending at the merits stage before this Court. The petition was granted on January 8, 2021, and the brief for petitioner and joint appendix are currently due on February 22, 2021.

In accordance with this Court's Rules 25.5 and 30.4, I respectfully request a 48-hour extension of time, to and including February 24, 2021, in which to file the brief for petitioner and joint appendix. This short extension will accommodate petitioner's efforts to deal with the massive fallout from the winter storm in Texas, including outages, flooding, and water-safety issues. The proposed extension would not shorten the briefing period for respondents, whose brief would still be due within 30 days of the filing of petitioner's brief; petitioner will make up any delay on the backend with the reply brief, thus ensuring the case is still fully briefed at the same time—and available for argument any day of the April 2021 sitting.
