**On A Petition For Writ Of Certiorari To The
Supreme Court Of New Jersey**

**MOTION FOR EXPEDITED CONSIDERATION OF THE
PETITION FOR A WRIT OF CERTIORARI AND FOR
EXPEDITED RULING ON THE MERITS IN THE EVENT THAT
THE COURT GRANTS THE PETITION**

Petitioner Hirsh Singh, Pro Se. moves, under Supreme Court Rule 21, for expedited consideration of the petition for writ of certiorari, filed today, to the Supreme Court of the United States. Expedited consideration of the petition for a writ of certiorari is warranted because of the imminence of the general election and the irreversible damage that it will cause to the Petitioner and millions of voters in New Jersey.

This case seeks to void the results of a primary election and the subsequent use of the candidates from that primary election in the ballots for the general election. Additionally, this case also seeks to overturn the new mail-in ballot system on the grounds that the portion of the election controlled by the United States Postal Service is not transparent and violates the Freedom of Information Act.

Petitioner respectfully requests that the Court decide this case on the merits before Election Day on November 3, 2020, as a decision before Election Day disallowing the mail-in

voting system will allow voters to take a decision to vote in person without these voters getting disenfranchised.

Petitioner proposes that Respondents be directed to file any response to the petition on or before Friday, October 30, 2020, and the Court treat the briefing on the petition as merits briefs and decide the case without either a reply brief from the Petitioner or an oral argument. In the alternative, Petitioner requests that the Court set an expedited schedule for briefing and argument in this case.

The new Senate will convene on January 03, 2021, and a decision on the merits would not be possible under regular schedules. If Cory Booker, Petitioner's opponent in the Democratic Party, takes office on this date, it will be impossible to repair the damage that occurred based upon an unconstitutional primary election.

For all of these reasons, Petitioner respectfully requests
that the Court grant expedited review of the petition for
certiorari and of the merits of this case.
