Dear Clerk Harris:

Pursuant to Supreme Court Rule 30.4, Respondents Jacob Rimler, et al., respectfully move for an extension of time for filing their response to Petitioners Postmates, LLC fka Postmates, Inc.'s (hereinafter "Postmates") Petition for Writ of Certiorari until December 1, 2021. The response is currently due on October 20, 2021.

The parties in this case have reached a class action settlement which would resolve all claims in this case, which has been filed in San Francisco Superior Court. See Rimler v. Postmates, Inc., Case No. CGC-18-567868 (San Francisco Superior Court); Postmates Classification Cases, Case No. CJC-20-005068 (San Francisco Superior Court). The settlement was preliminarily approved by the Court on August 12, 2021. The final approval hearing is scheduled for November 3, 2021. Assuming that the Court grants final approval, this case will be moot.

Accordingly, in the interest of judicial economy, counsel for Respondents respectfully submit that their response deadline should be extended until December 1, 2021, after the final approval hearing.
