
Pursuant to Rule 15.3 of the Rules of this Court, Respondents Global Witness Publishing, Inc. and Global Witness (together, "Global Witness") respectfully request a 30-day extension of time from August 27, 2021 to and including September 27, 2021, within which to file a brief in opposition to the petition for a writ of certiorari that was filed by Petitioners Christiana Tah and Randolph McClain ("Petitioners") on July 26, 2021.

On August 10, 2021, counsel for Global Witness was contact by a representative of the Beverly Hills Bar Association and the California Society of Entertainment Lawyers, who sought consent from Global Witness to file an amicus curiae brief on behalf of those organizations in support of the petition for certiorari. On August 12, 2021, Global Witness responded that it would not oppose a motion for leave to file an amicus brief.

Pursuant to Rule 37 of this Court, the proposed amicus brief in support of petitioners is due on August 27, 2021. An extension of 30 days in which Global Witness may file its opposition to the petition will permit Global Witness to respond to any arguments in that amicus brief in addition to the petition itself.

Accordingly, Global Witness respectfully requests that its application for a 30-day extension of time within which to file an opposition to the petition be granted.
