Dear Mr. Harris:

The petition in the above-captioned matter was filed on April 19, 2022. The case was placed on the Court's docket on April 21, 2022. On May 2, 2022, respondent PJM Interconnection, LLC waived its right to file a brief in opposition. On May 20, 2022, the Court requested that respondent file a response by June 21, 2022. Pursuant to Supreme Court Rules 15.3 and 30.4, respondent respectfully requests a thirty (30) day extension of time, to and including July 21, 2022, in which to file its brief in opposition.

The extension is necessary because of the press of other matters, including a response to a petition for rehearing en banc in *Continental Automotive Systems, Inc. v. Avanci, L.L.C.*, No. 20-11032, due in the Fifth Circuit on June 6, 2022; a meeting with the U.S. Solicitor General's office on June 13, 2022, in connection with this Court's invitation for the Solicitor General to file a brief in *Amgen Inc. v. Sanofi*, No. 21-757; a brief in opposition to judgment as a matter of law in *Lambeth Magnetic Structures, LLC v. Seagate Technology (US) Holdings, Inc.*, No. 16-cv-538, due in the U.S. District Court for the Western District of Pennsylvania on June 17, 2022; an opening brief due in *In re LTL Management LLC*, Nos. 22-2003 through 22-2011, due in the Third Circuit on June 30, 2022; a response brief in *Netflix, Inc. v. DivX, LLC*, Nos. 22-1203 and 22-1204, due in the Federal Circuit on July 6, 2022; a petition for rehearing and rehearing en banc in *Arthrex, Inc. v. Smith & Nephew, Inc.*, No. 18-2140, due in the Federal Circuit on July 11, 2022; a principal brief due in *The Regents of the University of California v. The Broad Institute, Inc.*, Nos. 22-1594 and 22-1653, due in the Federal Circuit on July 11, 2022; and an anticipated amicus brief due in this Court on or around July 15, 2022.
