Dear Clerk Harris:

Pursuant to Supreme Court Rule 30.4, Respondent Wendy Santana (“Respondent”) respectfully moves for an extension of time to file her response to Petitioner Postmates, LLC, fka Postmates, Inc.’s (“Petitioner”) Petition for Writ of Certiorari by ninety (90) days to August 11, 2022. The response is currently due on May 13, 2022.

The parties in this case have reached a class action settlement that will resolve all claims in this case, which has been filed in San Francisco Superior Court. See Postmates Classification Cases, Case No. CJC-20-005068 (San Francisco Superior Court). The settlement was preliminarily approved on August 12, 2021. The parties are awaiting the San Francisco Superior Court to schedule a continued final approval hearing pursuant to the minutes attached hereto as **Exhibit “A.”** The parties anticipate that the San Francisco Superior Court will grant final approval and this case will be moot.

Accordingly, in the interest of judicial economy, counsel for Respondent respectfully submit that her response deadline should be extended until August 11, 2022 to allow time for the settlement to be fully funded.
