MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

The petitioner seeks leave, pursuant to Sup. Ct. R. 39, to file the attached petition for a writ of certiorari without payment of costs and to proceed *in forma pauperis* and without prepayment of fees. In support of this Motion, counsel submits the following:

1. Petitioner is a Tennessee death row inmate. *State v. Hall*, 8 S.W.3d 593, 595 (Tenn. 1999).

- 2. In proceedings below, Mr. Hall was found to be indigent and entitled to appointment of counsel pursuant to 21 U.S.C. § 848, and the Federal Public Defender for the Middle District of Tennessee was appointed to represent him.

 . Hall v. Bell, 05-01199 (W.D. Tenn. Dec. 5, 2005) (Order) (R. 5, PageID 1–3). The district court also ruled Mr. Hall was entitled to proceed *in forma pauperis*. Hall v. Bell, 05-01199 (W.D. Tenn. Dec. 5, 2005) (R. 6, PageID 4–6).
- 3. Before the Sixth Circuit Court of Appeals, Mr. Hugueley was found to be indigent again and allowed to proceed *in forma pauperis*. *Hall v. Mays*, 15-5436 (6th Cir. Oct. 11, 2016) (Order) (ECF 12-2).
- 4. Mr. Hall remains indigent today, as he has throughout his criminal proceedings and subsequent period of incarceration. His inmate trust account statement, attached hereto, demonstrates that he is unable to pay the fees and costs associated with the filing of the accompanying petition.
- 5. Petitioner respectfully moves this Court to allow him to proceed *in forma* pauperis.
