Dear Clerk of the Court:

On August 29, 2022, the Honorable Justice Sonia Sotomayor denied Petitioner Anthony Marciano's Writ of Injunction in the above-referenced case filed August 25, 2022. Pursuant to U.S. Supreme Court Rule 22.4, Petitioner hereby respectfully resubmits the Application for Writ of Injunction to the Honorable Justice Clarence Thomas for the requested Emergency Relief.

Attached hereto as Exhibit One is an August 31, 2022, denial of an appeal to an Exemption Request to excuse Petitioner from a Covid 19 vaccination employee mandate, a.k.a. "Vaccination Orders," imposed on all City municipal workers on October 30, 2020, by Respondent(s) Mayor Eric Adams and the New York City Police Department. According to the exemption denial, Petitioner must be vaccinated with Covid 19 by Wednesday, September 7, 2022, or he will be placed on Leave Without Pay (LWOP), and terminated within (3) days from his job as a Detective with the N.Y.P.D. Due to the holiday weekend, Petitioner has no choice but be vaccinated before Wednesday morning to comply with the Vaccinations Orders, without an Emergency Stay being granted from Your Honor, pending the outcome of his appeal of his case, currently pending in the United States Court of Appeals for the Second Circuit. (Dk. No.: 22-570).

Petitioner filed his Writ of Injunction in this Court, on behalf of himself, and all others similarly situated refusing an Emergency Use Authorized (EUA) Covid 19 mandate, that under state and federal law may not be mandated on anyone without informed consent or judicial order of quarantine. 21 U.S.C. § 360bbb-3(e)(1)(A); New York State Public Health Law, NYS PHL §2120 (3). Specifically, under PHL §206(1)(l) and §613, adult vaccination mandates are prohibited in NYS, as a matter of law.

Your applicant is forwarding ten (10) copies of the original application and proof of service as required by Rule 29 by US Mail. Such original application was filed electronically August 25, 2022 and docketed on even date.
