Writ of Certiorari and Stay without 10 days' advance notice to the parties of Amicus's intent to file

as ordinarily required.

In light of the expedited briefing schedule set by the Court, it was not feasible to give 10

days' notice, but *Amicus* was nevertheless able to obtain a position on the motion from Applicants.

and visited political prisoners.

University graduates in countless synagogue pulpit positions and that Yeshiva University should

have the "... right to uphold religious liberty in the Application of its Torah values ..."

For the foregoing reasons, proposed *amicus* respectfully request that the Court grant this

INTEREST OF THE AMICUS CURIAE¹

Chief Rabbi Ephraim Mirvis is the Chief Rabbi of the United Hebrew Congregations of Great Britain and the Commonwealth. He is, consequently, the primary Jewish Rabbinical figure in those areas and is able to indicate the international position of Yeshiva University not merely for the United States but for Jews throughout the world. Yeshiva University is the flagship Jewish University, is guided by Torah values, and trains the next generation of Modern Orthodox leaders.

Amicus Chief Rabbi Ephraim Mirvis believes that Yeshiva University graduates have had great influence in countless synagogue pulpit positions and that Yeshiva University should have the "... right to uphold religious liberty in the Application of its Torah values . . ."

Protecting Yeshiva University's religious autonomy is crucial to safeguard those values that are threatened but are guaranteed by the Constitution, including protecting the right of religious institutions to exercise their own mission and to prevent State involvement in religious doctrine.

ARGUMENT

Yeshiva University is the flagship Jewish University, is guided by Torah values, and trains the next generation of Modern Orthodox leaders. Yeshiva University, as religious organizations and institutions generally, must be free to make its own decisions regarding theological religious matters, free of government interference.

The statement of Chief Rabbi Ephraim Mirvis indicates how important it is for Yeshiva University to have the ability to determine its own policies, procedures, and practices based upon Modern Orthodox Jewish Religious strictures and requirements, which Yeshiva University has always fostered and maintained.

Yeshiva University, although located in the United States of America, is in fact, known throughout the world in the Modern Orthodox Jewish community, for the leadership of its senior Rabbis and for its adherence to tradition and Torah values. Its ability to so continue is vital, and the statement of the *amicus* annexed hereto indicates why this matter is of great significance, not merely for Yeshiva University in the United States of America but also for its international renown and status.

Because the court below disregarded Yeshiva's own religious explanations and its entire religious autonomy defense, the application should be granted.

CONCLUSION

To vindicate principles of religious autonomy protected by the First Amendment, the Court should grant the application.
