Re: Corrected application to Extend Time Writ of Certiorari

Dear Justice Sotomayor:

Mo No. 2022-133 the Court of Appeals, the State of New York, in which I was the plaintiff, was denied: decided and entered twenty-eight of April 2022. The court of origination is the Supreme Court, New York County. Defendants has caused a prolonged period of extreme hardship. On the 1st Appellate Division, appellant invoked the Eight Amendment. Right now, not only my financial situation is such that I would have to proceed as forma pauperis. My housing situation is dire as well, it is only temporary.

Wherefore, an Extension of Time is requested so that I can improve my financial situation and can secure a more permanent housing arrangement. Because of the large amount of uncertainty of circumstances, the maximum time permissible is requested with a preferable minimum time of 60 days.
