Dear Mr. Harris:

The Third Interim Report of the Special Master was ordered filed on July 24, 2023, and exceptions to the Report, with supporting briefs, are currently due on September 7, 2023.

On August 31, 2023, we submitted a request for an extension of the time for filing exceptions to the Report and supporting briefs, as well as subsequent filings. In this letter, we respectfully modify that request as follows:

Because of scheduling difficulties and the press of other cases, the parties respectfully request, under this Court's Rule 30.4, that the time within which to file exceptions to the Report, with supporting briefs, be extended to and including October 6, 2023, and that the time within which to file replies, if any, with supporting briefs, be extended to and including December 4, 2023. If those extensions are granted, the sur-replies, if any, with supporting briefs, would be due on January 3, 2024.
