I am counsel of record for the Petitioners in the above case at Docket No. 23-1108. I write to supplement the Statement of Related Proceedings in our Petition for Writ of Certiorari filed on April 8, 2024.

On May 7, 2024 after the Petition for Certiorari was filed with the Court, Adult Probation Officer Daniel Kinsinger filed a Petition for Writ of Certiorari captioned Daniel Kinsinger v. Sherelle Thomas, Administrator of the Estate of Terelle Thomas et al., docketed at No. 23-1204 (noted above). Officer Kinsinger's Petition arises from the same incident, seeks review of the same decision by the Court of Appeals for the Third Circuit and implicates many of the same issues as the Petition docketed at 23-1108. Therefore, please accept this supplement in accordance with Supreme Court Rule 14.1.(b).
