**MOTION FOR LEAVE TO DISPENSE  
WITH PREPARATION OF A JOINT APPENDIX**

Pursuant to Supreme Court Rule 26.8, Petitioners in the above-captioned matter respectfully move for leave to dispense with the requirement of a joint appendix in this case. Respondent agrees that a joint appendix is not necessary.

This case presents purely legal questions: Whether the allegations in Respondent's complaint (i) satisfy proximate cause, and (ii) state a plausible aiding-and-abetting violation, such that the complaint is not barred by the Protection of Lawful Commerce in Arms Act.
