Dear Mr. Harris:

The Court docketed the petition for a writ of certiorari in the above-captioned case on July 1, 2024. Respondents waived response on July 29 and 31, 2024. On August 21, 2024, the Court called for a response. On September 9, 2024, the Court granted Respondents' motion to extend the time to file their brief in opposition. The brief is currently due October 21, 2024.

Pursuant to this Court's Rules 15.3 and 30.4, Respondents T. Anthony Mecklenburg and Catherine Mecklenburg respectfully request an additional 30-day extension, to November 20, 2024, to file their response. Petitioner does not oppose this request.

The extension is necessary given the heavy press of other business. Between Respondents' first motion and the requested deadline, undersigned counsel and his colleagues have needed and must continue to attend to deadlines in several matters, including a merits brief for respondents in *Republic of Hungary v. Simon*, No. 23-867 (U.S.), and several oral arguments and a number of briefs in the federal courts of appeals.
