Pursuant to Supreme Court Rule 30.4, the State of Tennessee respectfully requests an extension of 30 days, to and including February 2, 2024, within which to file its brief in opposition to the petition for a writ of certiorari in *Henderson v. Pounds*, No. 23-6160. The Court docketed the petition on December 4, 2023. The State's response is currently due on January 3, 2024.

This is the State of Tennessee's first request for an extension of time. The extension is needed in light of other deadlines and additional conflicts by the State's counsel of record, Nicholas S. Bolduc. During the briefing period, Mr. Bolduc must prepare responses to at least four to five petitions for a writ of habeas corpus along with other obligations.
