Dear Honorable Colm F. Connolly:

I brought this law suit since the Defendants (herein, referred to as the "state"), admitted it is persecuting me based on my beliefs in Jesus Christ (See State's petition at 7, **Exhibit A**), and for my religious-political speech, religious-political association, religious-political exercise, religious political beliefs, and religious political petitions, and petitions as outlined in my petitions. Per the Defendants August 23, 2021 letter, attached hereto as **Exhibit B**, Defendants admitted they attacked me, based on my Delaware Supreme Court and Chancery Court pleadings relating to religious-political activity, thereby interfering with a witness and party, me, in an active case, in collusion to affect my testimony, pleadings and the outcome of the case, to prevent appeal, in violation of 42 U.S.

Code § 1985 (2), and in violation of the procedural and substantive due process protections afforded to. (**Exhibit B**, August 23, 2022 Letter). Defendants refused to allow me to perform discovery or to cross examine my accuser, despite my, fraudulently undocumented request at the hearing, omitted from the transcript to commit deception in the fixed proceeding against me.

I desired to question my accuser, Patricia Swartz, and her coconspirators, on how my religious-political petitions, based on my religious-political beliefs, religious political-exercise, and religious-political and other association as a Child of God, an active citizen in politics, a Democrat, a Christian, an impoverished, attorney, behaving as a party in a proceeding caused concern enough to interfere with my fundamental rights. I was not afforded opportunity to perform discovery, call witnesses or to ask my accusers by cross examine why she alleged my pleadings before the Delaware Supreme Court and Chancery Court warranted violating my substantive and procedural due process rights, my rights under the Equal Protections Clause from disparate government treatment for exercising Constitutionally protected activity, my right to petition the court for grievances, to speak, exercise religious and political beliefs, freedom to believe religious-political beliefs by the dictates of my conscience not the dictates of state through its government bought private partners, churches or otherwise, who I believe will go to hell for selling my God's name to market business not good, not God's will, not

charity, and my freedom to exercise my religious-political beliefs without government incited private and public persecution for being a follower of Jesus Christ. I desired to perform discovery, go through the documents, to cross examine my accusers, and coconspirators to show the alleged concern the Defendants have is disagreeing with my religious beliefs in Jesus Christ, which heavily influence my political beliefs, association and exercise, and life.

Defendants do not understand that, my license to practice law is necessary for me to obey God to seek justice on behalf of myself, on behalf of Jesus Christ, and the oppressed is my security not mere business or money. Nor do they understand the license to practice law is a religious exercise, not merely about making money by free choice, not forced choice. They seek to take away my ability to exercise my religious belief. Justice by just decrees is a command by God. *Amos 5:15, Matthew 23:23*. God teaches damned to hell are those who render unjust decrees, doing what they were told, and following the letter of unjust statutes or prior case law, will not save them from failing to use their independent conscience mind, to care to know, in order to love, should they not repent. Jesus the Christ teaches few people go to heaven. Many try thinking they will get there, but the way is hard and they will be thrown into the fires of hell for their misunderstanding which is sad. *Matthew 7:13-15, Luke 13:23-28*.

My beliefs are unflattering to those in authority. Jesus teaches most people go to hell. Jesus teaches those in authority who look at the people for productivity, money and material gain, will perish as children of the devil, not protecting freedom but slavery, selling those they serve, other people's souls to private and public partners. Such leaders are twice dead and will be deemed dirty whores, not brides of Jesus Christ should they not repent. Whores is a biblical term, it is one of God's words for the twice dead, for those without eternal life, should they not repent of filthy lusts for money, lustful, distracting, loveless merriment, and material gain, only to lose their soul from such worldly aka antichrist thinking and antichrist doing.

I believe people go to hell for organized charity, fundraising and donations, in direct disobedience to Jesus's commands against this false charity, and for failing to do true charity at a worldly loss for a Godly gain. The past few years as I fought the hypocrites who put on a show to combat racism and other evils through my articles of impeachment and legal proposals that actually alleviate the burdens off the backs of the people while safeguarding their freedom. I did true charity in secret behind closed doors, seeking to move mountains, by moving cold hearts, to care for, not exploit. The least of these are victims of designed oppression for debt control, power and profit of wolves. They are not the problem. Those who exploit them who serve lawless lusts under the guise of the rule of law, under the illusion

of charity, and the wicked job creation in a fixed, not free economy are in the wrong in need of Court correction, or at least God's guidance to escape being thrown into the fires of hell.

Defendants' agent, De-Lapp, Court of Common Pleas Judge Kenneth Clark, and Court staff also colluded, in a conspiracy, to interfere with my active case, *Kelly v Trump*, to pressure me to forgo my case or to affect the final outcome before the US Supreme Court. (D.I. 2, the Complaint where I outline the state's misconduct, D.I. 2, D.I. 4 at Exhibits A-4, A-5, D.I. and D.I. 7 at Exhibit 1, also attached hereto as **Exhibit C**, the threatening Letter, dated May 24, 2021, De-Lapp sent to me during my active case *Kelly v Trump*, D.I. 7 at 2, D.I. 4 Exhibit 46, the Newspaper article I drafted in the Coastal Point local paper proposing a solution to this problem). These attacks are based on their disagreement with my religious-political beliefs, outlined in my pleadings, they find unflattering to the State's and Defendants' selfish, not serving goals.

Defendants appear to have a problem with my petitions to the government for unethical state behavior. On January 31, 2022, Patricia Swartz included documents I sent to her office, protected under confidentiality, now broken by her by her submission in the State's proceeding which is public on appeal to the US Supreme Court, relating to unlawful agreements to allow out of state title companies to practice law without a license, while hiring Delaware lawyers as

independent contractors, and advertising their lawyers and placing them on their title Companies advertisement, in violation of DLRC Rule 5.4, by allowing Delaware law firms to share fees with nonlawyers for lawyer work, excluded as an exhibit to protect my deceased friend's reputation and lawyer communications seeking lawyer advise amongst colleagues, attorney client privilege, and the confidentiality required by the ODC to resolve the issue, albeit it appears the ODC violates that confidentiality rule by including it in public appealable proceedings, open to the public on appeal. (D.I. 9 at Exhibits 1-9, please see the table of contents too.)

I ran for office because I discovered 100s of thousands of dollars were not getting into the Delaware coffers relating to real estate settlements. (D.I. 4 at 46). Out of state title companies were, and allegedly still are likely practicing law without a license, not paying taxes and messing up chains of title per colleagues. I complained to the ODC. They ignored my concerns. The recently deceased Justice Holland offered to help, but the problem still persisted. I asked law makers for help to no avail.

So, that is why I ran for office in 2018. No one else was going to prevent harm. So, I was going to do what I thought was right. I drafted an article in the newspaper to guide law makers on how to eliminate the problem. Id.

I didn't file the attached letter, labeled as **Exhibit D**, but I drafted it relating to lawyer misbehavior too, and sent it to Patricia Swartz. She is charged with correcting, not condemning those misguided by money, convenience and self-interest to be guided to serve, not exploit customers and the public for money. Patricia Swartz included it as part of the state's exhibits, and appears to have a problem of improving the profession by shedding light on corruption within.

**(Exhibit D)**

Lawyers should not self-regulate, because we look after our own at the public's expense. The state provided this as an exhibit in the state proceedings. I gave it to Patricia Swartz to show her bad lawyer misbehavior, where we lawyers misbehave to serve ourselves at the public's expense which is not serving justice.

I also sent Patricia some of my concerns to prevent the planned, preventable elimination of physical currency to crash the global economy, including entities developing Green and Clear Pass used to track Covid-19, some entities apparently developed before the pandemic, which she attached as the Defendants Exhibits on January 31, 2022. **(Exhibits E, F, G)** These entities track people under the guise of caring for them, to control them. As the Book the Fourth Industrial Revolution referred to the elimination of lawyer jobs, by automation in my exhibit at page 39. The back door former President Bush, Junior opened up, opens us up to harm under the guise of safety, control by those who use, not care for us, for needless

jobs, and busy work for insurance, lawyers, and cyber security threats, which are preventable with the rule of law, should congress use their pens to make us freer, safer and cared for. See also **Exhibit H**, where I lamented to needless, manufactured by design dangers and preventable, manufactured costs and other concerns how the lawyer trainings violate my religious beliefs. (**Exhibit H**, also found at D.I. 3 at District Court Exhibit 5). The back door Bush opened up will allow the dissolution of the dollar, the fall of the global economy, to be replaced with something far more sinister, which violates my religious beliefs on a greater level, under the tools of the Fourth Industrial Revolution, Great Reset, and the not so green global plans where the economy will be a debtor system on a far worse level than slavery, indentured servitude, fiefdoms, socialism, or our fake capitalism, where the markets are fixed, not free in violation of freedoms. Debt is against my religious beliefs as I am not a slave to man, nor are people to be deemed slaves for money and material gain by those who control them under the guise of caring for them. It is horrific, and given an opportunity, I should like to prepare this Court to save the world in another case. I am being persecuted for my political beliefs so this is in issue.

I alerted the Chancery and the Delaware Supreme Court of my concerns about an economic crash per, but not limited to the attached letters Exhibits I and J. In the letter, dated October 19, 2020, I indicated the Chancery Court was the only

court in the universe with corporate connections around the globe who may reverse or prevent a crash, relating to corporate constitutional law, and global ties. Id.

Upon consideration, the Delaware District Court may also prevent or reverse the planned crash, should someone with standing sue President Biden for a writ of mandamus to require he compel Secretary of Treasury Janet Yellen to coin money without interest or debt, to pay off debt, especially money owed to the baby boomers for healthcare and retirement, to prevent the elimination of the physical dollars, and a global crash pursuant to 31 U.S.C. § 5112 (k).

Albeit additional law suits may be needed to root out corruption in banking, and in congress to make people free, not for sale human capital to the government's private partners abroad or at home.

My religious and political beliefs are in issue. Per the attached pleading, as an example of Bible verses accepted as authority by the United States Supreme Court, I am permitted to speak on the bible and my religious beliefs as facts, as truth, not a matter of debate to me, even if this court respectfully disagrees with me. (Exhibit K).

Neither money, nor weapons may save the world, but your conscience choice to use your honor's free will to think, to know, in order to care about humanity to safeguard Constitutional liberties from dissolution by unraveling the union of Constitutionally protected beliefs in free will, the source of every

freedom, from the lie, the scientifically or chemically or physically or socially conditioned, conformed lawless mob reign of lusts is for the good of humanity and the world. Those who speak against disorder and call for “law and order” reflect the image of Satan to serve lusts and control, not God’s law of love, allowing freedom to choose, even freedom to choose differently or make bad choices. Equality is not freedom, but forced control, by elimination of choices in pursuit of sameness, uniformity, standardization to control not care for, for wicked convenience and costs, at the cost of liberty. Standardization, stifles free thought and improvement to serve the satanic desire for order, convenience and control over people, not safeguarding freedom. Without protecting freedom of conscience, people will likely go to hell, because it must be a free not forced choice, to unconditionally love, not conditionally care under economic, physical or social peer pressure. I desire to protect people’s freedom to even disagree with me, to think, to know, to love or not. When we force our will upon others, that is not law, but lawless lusts by those in positions of power who protect their seats over those they serve.

Free will must be protected from the lie there is no choice. There is always a choice between evil and good. Citing, 1 *Corinthians* 10:13. When the government through government backed partners serve the lawless reign of lusts, for convenience, costs, greed, gluttony and lustful good times or other sins, thereby

serving the “lawless one,” the Fallen Angel, under the guise of the law and order, the mark of the beast, business greed and gain, then, lawlessness and injustice reigns.

When I ran for office, I did not want to force my will upon others, reflecting the image of Satan who controls the world. I seek to protect people’s freedom to think for themselves even disagree with me and the government, as the Constitution requires, and as God requires. People go to heaven only if they freely unconditionally love. Peer pressured, societal peer pressure by praise or ridicule, economic or physical government incited pressure to conditional conform, or conditionally care, is not unconditional love, but is the mark of the beast, meaning the mark of those twice dead not yet born into eternal life, should it drive out love from the hearts of man.

We need the court to tame the beast, sin, with the just rule of law to guide the misguided by rendering true justice protecting even those you are correcting with mercy. I believe people go to hell for their misunderstanding per Jesus’s teachings in *Matthew* 13, and for their confusion per 2 *Corinthians* 4:4. I believe judges have the power to save not only lives but eternal lives too by their conscience choice to care to know, to care to love, to care to guide and shepherd the flock in your charge, not eating them like wolves, as human capital for material gain.

The World Economic forum's cohorts and colleagues' scheme to teach the lie free will, may no longer be free through hacking humans with computers, to force human's will to their desires. They cannot read our minds as they deceive us to believe to gain endless funding for mad science for debt control. They may read our emails, so long as Bush Junior's door to our devices remains open, without requiring devices which truly protect our security. They scheme to create desperate conditions to use humans for mad science under the guise of mental health when in reality it harms health for their own profit and control. Our healthcare is so bad. When I ran for office, I outlined ways to improve it. Our healthcare and mental healthcare damns people to hell too, as I alleged in my complaint. People go to hell for not knowing, not caring to know, for selling their souls for a salary, what God calls whores, blinding their eyes for money or convenience. It is no small sin to harm life and health. The shield of the word "we didn't know" and "science" and "learning" will condemn men to hell, not excuse them should they not repent by unhardening their heads, hearts and hands.

Recall Banks, including central banks, including the federal reserve and scientists get more money the worse off humanity is, the more debt, waste, debt and dying there are. There is incentive to kill, steal and destroy to serve the mark of the beast, business greed. If scientists, and experts fixed problems, funding would end, and they would be out of a job. The global term "sustainable

environment” is bad for the environment and humanity. Their goal is sustaining debt, and artificially created need to serve their greed, in a borrowing society, which creates more pollution by creating made to disintegrate products, that pollute in production of replaced products or services, and pollute in the delivery of rented out items, where the world economic forum founder claims “no one will own anything and be happy.”

I ran on a platform to clean and safeguard the environment through just decrees that cared for humanity, requiring made to work, made to last products, not unjust decrees that allow the wealthy to stock up on dirty products, then make the common man pay more or go without to reduce the common man’s use by increasing taxes, costs in a manufactured not free economy, and penalties, as pollution continues in production of worse products and services.

I fear God, I am not going to sacrifice people or the environment for the bottom line. God will throw men into the fires of hell the last day for destroying God’s temple, that means people, and for destroying the environment.<sup>1</sup>

There is a clear distinction between just laws and unjust laws. Compromise means injustice and to God damnation in hell, should those who sell justice by

barter or exchange as opposed to impartially rendering justice, regardless of monetary cost or convenience, not repent. Compromise is a bad word. Mercy is a better word, where there is grace as opposed to compromising evil for good.

Unjust laws serve lawless lusts and unconstitutional control by those with power, money, or connections, while crying out the deception of “law and order” to punish use of free will, constitutional freedom to think and disagree, even through peaceful protests, under the guise of disorder. See *Isaiah* 14 to see how Satan wanted to live based on his desires, instead of laying down his desires to love God or others as self.

People are free, not human capital. God will throw men into the fires of hell for looking at humans as capital, or for productivity, should they not repent.

People are God's, created because God loves them, regardless as to whether they accept and reflect that love. People are not slaves to their country or to mere man to be sacrificed to leaders who behave as wolves in shepherds clothing.

The laws and policies schemed ahead serve lawless lusts, and organized pro bono, volunteering, charity and fundraising which damns people to hell per Jesus the Christ. (See Exhibit L)

In *Matthew* 6:1-4 Jesus says do not give charity seen like the hypocrites who will have no reward from their father, meaning no eternal life or salvation from being thrown into the fire of the second death. Jesus teaches when you give charity do not know your left hand from your right, meaning do not give to get. The Government is corrupted to control the people, instead of care for the people. You may have the power to eliminate the corruption by eliminating the temptations to harm people for position, profit, and power or praise.

The system is corrupted to guarantee injustice, and I ask your consideration to make the government freer, fairer by taking away the temptations, rewarding evil as good, before it is too late, and lawyers and judges and governments are eliminated as schemed. See page 39 of the Fourth Industrial Revolution to confirm lawyer jobs will be reduced to eventually be eliminated.

**ODC’S PETITION TO TRANSFER MEGHAN M. KELLY, ESQUIRE  
TO DISABILITY INACTIVE STATUS**

COMES NOW the Office of Disciplinary Counsel (“ODC”), by and through its counsel, Patricia Bartley Schwartz, and hereby petitions the Board on Professional Responsibility of the Supreme Court of Delaware (“Board”) to transfer Meghan M. Kelly, Esquire (“Respondent”) to Disability Inactive Status (“Petition”) pursuant to Rule 19(c) of the Delaware Lawyers’ Rules of Disciplinary Procedure (“Procedural Rules”). In support of its Petition, ODC avers the following:

1. Respondent is a Delaware lawyer admitted to the bar of the Delaware Supreme Court in 2007. Respondent is currently eligible to practice law, with no conditions or restrictions.
2. Delaware lawyers have a duty to conduct themselves in conformity with the standards imposed on members of the bar as a condition of the privilege to practice law.

6. In September 2020, Respondent filed a lawsuit in the Court of Chancery of Delaware against former-President Donald Trump: *Meghan Kelly v. Donald Trump*, Case No. 2020-0809 (September 21, 2020). The Court of Chancery dismissed Respondent's complaint. Respondent appealed to the Supreme Court of Delaware, which affirmed the Court of Chancery. On August 23, 2021, Respondent filed a writ of certiorari with the Supreme Court of the United States.

7. The factual averments, argument, and other content in Respondent's filings in the Delaware courts, raise serious concerns regarding her mental capacity to practice law. Respondent's statements and arguments: lack focus and clarity; are objectively illogical; and rely on non-legal sources, including the Bible, instead of appropriate legal authority. The following excerpts demonstrate, by way of example only, Respondent's apparent inability to make cogent, rational legal arguments:

13. The President's words and conduct supporting religion, as discussed below, were accepted as truth by many, thereby, instilling the belief, supporting the President's perceived thinking or conduct or his candidacy, despite all of his sinful misbehavior and in a way supporting his sins, as excusable without confession or without repentance, is supporting God, when I believe sinfully doing your own will leads to damnation. (Mark 8:34, ""Whoever desires to come after Me, let him deny himself (meaning not doing their own will, their own selfish, sinful desires, but exercise self-discipline, using their mind, their brain, which is their free will to do God's will, love), and take up his cross, and follow Me (by love in truth, not lusts in deception)."""); Also see, (Matthew 16:24, Luke 9:23 regarding the same message of personal sacrifice to follow Jesus).

**RE: ODC File No. 115327-B (Meghan M. Kelly, Esquire)**

Dear Ms. Kelly:

This Office has reviewed several pleadings you have filed in the Court of Chancery and the Supreme Court in connection with the lawsuit *Meghan Kelly v. Donald Trump*. The content of these documents raise serious concerns as to your mental capacity and fitness to practice law.

Under Rule 9(a) of the Delaware Lawyers' Rules of Disciplinary Procedure, the ODC "shall screen and evaluate all information coming to its attention by complaint or otherwise concerning possible misconduct by or incapacity of a lawyer." Procedural Rule 19 (c) provides "Information relating to a lawyer's physical or mental condition which adversely affects the lawyer's ability to practice law shall be investigated by the ODC. If there are reasonable grounds to believe the interests of respondent's clients or the public are endangered, such information shall be the subject of formal proceedings to determine whether the respondent shall be transferred to disability inactive status. The procedures and hearings shall be conducted in the same manner as disciplinary proceedings. The Board may take or direct whatever action it deems necessary or proper to determine whether the respondent is so incapacitated, including the examination of the respondent by qualified medical experts at the respondent's expense. If, after reviewing the recommendation of the Board and upon due consideration of the matter, the Court concludes that the respondent is incapacitated from continuing to practice law, it shall enter an order transferring the respondent to disability inactive status for an indefinite period and until further order of the Court."

APPELLANT’S UNOPPOSED MOTION FOR THE DELAWARE SUPREME COURT TO ACCEPT HER WAIVER OF A SPEEDY DECISION

1. I, Meghan Kelly, pro se appellant, having been granted in forma pauperis relief, move this honorable Delaware Supreme Court, waive my right to a speedy determination by this Honorable Court.

2. I desire more time. The Defendant President Biden is not prejudiced. I sent the Delaware US Attorney Generals Merrick Garland (“AG Garland”) and David Weiss (collectively “AGs”) a copy of the notice of this appeal, and I think I indicated I hope the attorney generals could somehow persuade this court to save the world possibly outside of my case. President Biden through the Attorney Generals has notice of this pending case.

3. I think I need more time to discern strategies, and persuade others to ask the Chancery Court to save the world.<sup>1</sup> There is so much evil the Delaware

received pay in return for giving the state of Delaware construction leases above and below the property, as approved by Sussex County Counsel. While, the state espouses the aim of preserving farms, the state will be tempted by harder economic times, as will farmers, and will be the only ones willing to buy farm land others cannot build on. By the doctrine of merger, the state through its employees may get the land in toto to invest, lease, sell and profit off of personally by trading favors with entities or people to serve their seat or own gain. Who will correct the

government from misbehaving? Who will have standing? How can we reduce temptations for government agents from giving into temptation to harm people's lives, health and the environment to serve business greed, by barter or exchange, the mark of the beast, not mark of good or love.

5. I am troubled that the state may assess land at an inflated price before an expected depreciation in value will hit, preventing potential home owners from buying a home by rendering it unaffordable by increased taxes, and possibly pushing others out of their home. If the state paid government for specific work performed, strings attached, without paying private entities as opposed to people, they could fully fund schools and the government without property taxes. But instead, the government not only increases taxes to provide monetary breaks and benefits to artificial beasts without hearts, entities, businesses and not for profits ("beasts"), but it also encourages the way to hell by forced servitude by some seeking to stay alive by food stamps, rendering them slaves to the beasts, pro bono, or peer pressured reward, praise and shame. 6. Far worse, the proposed poop polluting factory that may be approved by Governor Carney's agent in the Seaford Laurel area will cause pollution, harm to human life and health and destruction to the environment. The plant allegedly will ship in out of state manure to dilute local chicken poop, which does not convert to energy well. Chicken poop creates more deadly pollution. As more factories and plants are opened such as this plant, more of the common people will be forced to pay to clean up the messes of artificial entities without hearts, as their labor is exploited, their health is harmed and the environment is destroyed. How? Through sewer and city water increases? This will push a lot of people out of their homes, and the increased costs will prevent other people from buying homes, should the government partnered sponsored, allowed misbehavior continue.

8. Government partnerships with private entities, businesses, not for profits, charities and religious organizations is the source of evil and corruption in the world, and in the US. The law makers do not draft laws that prevent wrong doing by their partners. The executive and legislative branches reward wrong doers, by inter alias rewarding ignorance, stupidity, not knowing, delegation of duties and so much more. People go to hell for not knowing, for ignorance and stupidity. See, my brief below at 5.

9. There must be a division between the governing from the governed, to prevent the governing from colluding with the governed, the entities regulated under the law, to exploit the people they are charged to care for as slaves, human capital, indentured servants in violation of the thirteenth amendment, creating artificial debt to serve greed as opposed to individual need of each person worthy of dignity unearned, required.

10. The division of government and private industries must not only be required to prevent the government representatives from buying and bartering favors from private entities, by grants, bail outs or tax breaks or unenforceable laws that allow entities to murder for profit, by pollution, destruction to the environment, or using carcinogens in production of foods or goods or in products

or foods, but they should not be bought either. The Court must eliminate all money in elections, all filing fees and all signature requirements to run for office. Votes should not be bought by money, favors or signatures. Votes should be free in a representative government. Democracy should no longer be for sale.

11. With regards to partnerships which corrupt government employees' integrity from serving people they are charged to care for, not exploit for profit, the government must cut partnerships with entities abroad too. After all if they are investing money, people and resources with entities and organizations that may need government correction too, the bias may prevent the government from cutting off their own partnered hand.

12. There is such evil ahead. Global policies look like they will lead to a global famine. The US is not the only country that had large scale persecution towards migrants who desired to harvest fields, potentially creating fewer harvested crops.

13. There is also evidence of exacerbating inflation instead of alleviating it. For example, to save the post office, the federal government should reduce the price of postage to a quarter. That way people could afford to buy a stamp, and the post office would make money in bulk. The post office should also cut package rates in half to attract business away from competitors instead of towards competitors.

14. The post office is one of the few forms of speech that may not be easily manipulated, monitored, bought and sold by others.

15. There is evidence that global leaders, private and public, through organizations desire to digitalize everything, currency and shipments, and to artificially cut off shipments through electronic disconnections, hacks to manipulate markets to artificially inflate prices to force individuals in government private partnered forced servitude.

16. I recently discovered America was never free. This country has always been for sale, by those who steal it to sell it to those who barter for their favor or potential favor by donations, tax breaks, favors or support to government candidates or servants in exchange for unjust decrees that favor those who favor them or bailouts or worse to entities as opposed to individuals.<sup>7</sup> Please note, I believe people are thrown into hell for loving themselves first, loving their family first, loving those who affect them first as opposed to loving others as yourself. It is damnation guaranteed to exhibit such partiality and self-serving favoritism. This court must consider saving the souls of those within the government and saving

I do not think the mapped brain, identification map reduces prejudice. Instead it increases it. We should strive to respect every individual not based on association with others, but based on the fact they are an individual to be respected uniquely as every person should be.

The terms Miss, Mrs. and Ms. are similarly sexist, demeaning women by basing her name on marriage or not, whereas men all receive Mr. There is a rape crisis and a disgusting, ugly pride crisis men display by demeaning women down here, making jokes that are not funny.

Dear Honorable Master Griffin:

Thank you for taking the case.

I am not an attorney advocate in this case. I am without the insulation and protection of counsel. I am a pro se litigant. I am the party, not the party's counsel. If I was a mere attorney, an officer of the Court, as opposed to the party, it would be different. Lawyers are permitted to talk to judges, but not on matters relating to matters, ex parte. I am not allowed to talk to you ex parte period.

The court's staff adds a buffer, and are not the Judge on the case.

It is strange for the staff, and for me. For instance, I could not share the rules that required 60 day notice instead of 20 days notice to the staff ex parte to give to you, even though I had them in my hand, and the staff kindly said she could take them.

Instead, I must communicate with the defense counsel simultaneously, electronically, or by mail while speaking directly to this honorable Court.

I do not know whether this case will remain in this Court or be removed to federal Court. This area heavily supports President Trump. One of Defendant's biggest campaign contributors allegedly lives in Sussex, and Delaware's liason for President Trump, Rob Arlett, lives in Sussex.

Although I am cognizant of the pro Trump atmosphere in this county, I have faith in the fair impartial rule of law by this Honorable Court.

The federal courts are more of a concern for me. The President's sister presided as a judge in the Third Circuit until recently. In addition, the President placed two Third Circuit judges on his list of potential nominees for Supreme Court, creating a concern that the federal judges may be biased toward their colleagues' potential nominations at the death of the next Supreme Court justice, Justice Hardiman and Justice Phipps.

I believe this Honorable Court, from the smallest state, has more power to save the country than the Supreme Court.

This is the corporate capital of the globe.

The biggest government expense globally is healthcare. (See the web site cited in Second Amended Complaint ("SAC"), Count 234). The US spends more money on social security and healthcare than any other sector.

That fact is often hidden by discretionary charts, instead of mandatory spending charts. The US now must pay out more.

The country and the globe have the biggest bill in the history of the world that has fallen due, healthcare and retirement for the baby boomers. Those who value money more than humanity are seeking to get out of paying this earned and owed debt, by bad business. 

For quite some time, some analysts  
been considering a possible and

On the one hand (managing the economy sensibly), doubters  
of US dollar dominance point to the inevitable and sharp  
deterioration of the US fiscal position. In their mind, unsustainable  
levels of debt will eventually erode confidence in the US dollar.  
Just prior to the pandemic, US defence spending, plus interest on  
the federal debt, plus annual entitlement payments – Medicare,  
Medicaid and social security – represented 112% of federal tax  
receipts (versus 95% in 2017). This unsustainable path will  
worsen in the post-pandemic, post-bailout era. This argument  
suggests that something major will therefore have to change,  
either through a much reduced geopolitical role or higher taxation,  
or both, otherwise the rising deficit will reach a threshold beyond  
which non-US investors are unwilling to fund it. After all, the status  
of reserve currency cannot last longer than foreign confidence in  
the ability of the holder to honour its payments.

On the other hand (managing the US dollar sensibly for the  
rest of the world), doubters of the dollar's dominance point to the  
incompatibility of its status as a global reserve currency with rising  
economic nationalism at home. Even though the Fed and the US  
Treasury manage the dollar and its influential network worldwide  
with efficacy, sceptics emphasize that the willingness of the US

the 4.5% of new jobs created during the 1990s. This is corroborated by a recent US Economic Census, which sheds some interesting light on the relationship between technology and unemployment. It shows that innovations in information and other disruptive technologies tend to raise productivity by replacing existing workers, rather than creating new products needing more labor to produce them.

Two researchers from the Oxford Martin School, economist Carl Benedikt Frey and machine learning expert Michael Osborne, have quantified the potential effect of technological innovation on unemployment by ranking 702 different professions according to their probability of being automated, from the least susceptible to the risk of automation ("0" corresponding to no risk at all) to those that are the most susceptible to the risk ("1" corresponding to a certain risk of the job being replaced by a computer of some sort).<sup>23</sup> In Table 2, opposite, I highlight certain professions that are most likely to be automated, and those least likely.

This research concludes that about 47% of total employment in the US is at risk, perhaps over the next decade or two, characterized by a much broader scope of job destruction at a much faster pace than labor market shifts experienced in previous industrial revolutions. In addition, the trend is toward greater polarization in the labor market. Employment will grow in high-income cognitive and creative jobs and low-income manual occupations, but it will greatly diminish for middle-income routine and repetitive jobs.

**Money and taxation**

The on-demand economy is also raising serious issues with regard to tax collection, as it becomes much easier and attractive for transient workers to operate in the black market. While digitally mediated payment systems are making transactions and micro-transactions more transparent, new decentralized payment systems are emerging today, which could significantly hinder the ability for public authorities and private actors to trace the origin and destination of such transactions.

**Liability and protection**

Government-issued monopolies (e.g., the taxi industry, medical practitioners) have long been justified on the grounds that certain types of high-risk professions require a higher degree of scrutiny and should only be performed by licensed professionals so as to ensure a proper degree of safety and consumer protection. Many of these government-issued monopolies are now being disrupted by technological advances that enable people to interact with one another on a peer-to-peer basis and by the emergence of novel intermediaries in charge of coordinating peers and facilitating their interactions.

**Security and privacy**

Despite the transnational character of the internet network and the growing global economy, data rights and data protection regulations are still heavily fragmented. Rules around the collection, processing and reselling of personal data are well defined in Europe but are still weak or entirely lacking in many other jurisdictions. The aggregation of large datasets is making it possible for large online operators to deduce more information that was actually provided (either implicitly or explicitly) by users. User profiling through big-data analysis and inference techniques is opening the way for new, much more customized and personalized services, which can benefit users and consumers, but which also raise important concerns when

**\*1 Interest of Amici Curiae**

**The Southern Baptist Theological Seminary** ("SBTS") is the oldest of the six seminaries affiliated with the Southern Baptist Convention ("SBC") and is one of the world's largest theological seminaries, with a full-time enrollment of over 2,000 students. Located in Louisville, Kentucky, SBTS currently enrolls students from all 50 states and 41 countries.

SBTS exists to serve the churches of the SBC by training, educating, and preparing ministers of the gospel for faithful service. From its founding in 1859 until the present day, the SBTS charter asserts that "God alone is Lord of the conscience; and He hath left it free from the doctrines and commandments of men, which are in anything contrary to His word, or not contained in it." SBTS believes that the government mandate at issue in this petition infringes on that venerable tradition of religious liberty and freedom of conscience.

**The Ethics and Religious Liberty Commission ("ERLC")** is an entity of the SBC, the nation's largest Protestant denomination, with over 46,000 autonomous churches and nearly 16 million members. The ERLC is dedicated to engaging the culture with the gospel of Jesus Christ and speaking to issues in the public square for the protection of religious liberty and human flourishing. The ERLC is charged by the SBC with addressing public policy affecting such issues as freedom of speech, religious \*2 freedom, marriage and family, and the sanctity of human life. Religious freedom is an indispensable, bedrock value for Southern Baptists. The ERLC fears the government mandate at issue threatens the Constitution's guarantee of freedom from governmental interference in matters of faith, a crucial protection upon which SBC members and adherents of other faiths depend as they follow the dictates of their conscience in the practice of their faith.

**The International Mission Board ("IMB")** is an entity of the SBC dedicated to taking the gospel of Jesus Christ to all nations and peoples in fulfillment of the Great Commission found in Matthew 28:18-20. To achieve its vision of seeing a multitude of every people, tribe, and tongue from around the world come to worship and exalt Jesus Christ as Lord and Savior, the IMB employs more than 5,000 Christian workers.

**Dr. R. Albert Mohler, Jr.** is the President of SBTS, the flagship school of the SBC and one of the largest seminaries in the world. Dr. Mohler has been recognized as one of the leading intellectuals among American evangelicals, has been quoted in the nation's leading newspapers, and has appeared on numerous news and commentary television broadcasts. He has authored several books and is the editor-in-chief of *The Southern Baptist Journal of Theology*.

### \*3 Summary of Argument

Requiring Christians - including the Southern Baptist entities among the Petitioners - to choose between violating the Government's regulations or violating their sincerely held religious beliefs substantially burdens their exercise of religion in violation of the Religious Freedom Restoration Act and the First Amendment to the United States Constitution. A fundamental aspect of Christian doctrine is its requirement that faith must govern every

aspect of a Christian's life. As a matter of scriptural command, conscience, doctrinal tradition, and Southern Baptist teaching, the exercise of the Christian religion must guide and determine a Christian's decisions, words, and deeds in every facet of life, including seemingly "secular" matters like the administration of insurance and the provision of certain drugs and devices.

Because of the holistic nature of the Christian faith, Baptists throughout American history have discerned a spiritual obligation to interact with and influence the culture outside the church doors. This has historically included providing for and protecting the oppressed or defenseless, including the protection of innocent and unborn human life. Southern Baptists have spoken clearly in opposition to abortion and in support of their belief that life begins at conception, beliefs that are grounded in the words of Holy Scripture.

In light of the broad scope of the Christian faith and the Southern Baptist theological opposition to abortion, the Petitioners cannot, as a matter of doctrine and conscience, distribute abortion-inducing drugs and devices directly or indirectly by \*4 authorizing, obligating, or incentivizing a third party - and particularly their own third-party administrators - to use Petitioners' health plans to provide such drugs and devices to others. Scripture and Southern Baptist belief prohibit not only direct and personal wrongdoing, but also complicity in doing what the Christian believes to be sin. Christian doctrine teaches that Christians who knowingly aid or abet another's wrongdoing have themselves done wrong. Accordingly, a statute or regulation requiring a Southern Baptist individual or ministry to be complicit in conduct the Christian faith teaches is morally wrong forces that person or ministry into an impossible choice - to either violate conscience or violate the law - and imposes a substantial burden on the exercise of religion.

### **Argument**

#### **I. Christian doctrine and Southern Baptist belief require that faith govern every aspect of a Christian's life.**

A fundamental aspect of Christianity is its requirement that the Christian faith govern all aspects of the believer's life. This teaching is drawn directly from the Holy Scripture and stems from the Christian belief that God's sovereignty extends over every area of human endeavor. *See, e.g., Psalm 24:1* ("The earth is the Lord's and the fullness thereof, the world and those who dwell therein.").<sup>2</sup> In the words of the English theologian and poet Isaac Watts, God's "love, so amazing, so divine, demands my life, my \*5 soul, my all." Isaac Watts, *The Poetical Works of Isaac Watts, Vol. IV* 173 (1782).

Accordingly, Christianity has never limited its reach merely to matters of theology and ceremonial observance. *See, e.g., Hosanna-Tabor Evangelical Lutheran Church & Sch. v. EEOC*, 132 S. Ct. 694, 713 (2012) (Alito, J., concurring) (agreeing with the Court's unanimous opinion that the job duties of a Lutheran minister engaged in education "reflected a role in conveying the Church's message and carrying out its mission" and observing that "[r]eligious teachings cover the gamut from moral conduct to metaphysical truth."); *Spencer v. World Vision, Inc.*, 633 F.3d 723 (9th Cir. 2011) (per curiam) (finding a Christian humanitarian organization " 'working with children, families and their communities worldwide to reach their full potential by tackling the causes of poverty and injustice' " was a religious activity); *see also* The Baptist Faith & Message 2000, Article XIII ("God is the source of all blessings, temporal and spiritual; all that we have and are we owe to Him.... [Christians] are therefore under obligation to serve Him with their time, talents, and material possessions; and should recognize all these as entrusted to them to use for the glory of God and for helping others."), *available* at <http://www.sbc.net/bfm2000/bfm2000.asp> (last visited August 7, 2015).<sup>3</sup>

Rather, Christianity teaches that one's faith influences even those areas of life that appear superficially unrelated to worship, prayer, or theology. *See, e.g., Colossians 3:17* ("And whatever \*6 you do, in word or deed, do everything in the name of the Lord Jesus."). Indeed, Christianity teaches there is spiritual significance in *every* part of life, including seemingly mundane acts like eating, drinking, and working. *1 Corinthians 10:31* ("So whether you eat or drink or whatever you do, do all for the glory of God."); *Colossians 3:23-24* ("Whatever you do, work heartily, as to the Lord."); *Ecclesiastes 3:1-13* (noting "[f]or everything there is a season, and a time for every matter under heaven" and that "everyone should eat and drink and take pleasure in all his toil - this is God's gift to man"). These holistic demands of Christianity require consistency in familial, business, and social relations and are not limited to sacerdotal, ecclesial, or ritual matters.

This integration of a Christian's entire life in relation to God is an outgrowth of the Christian gospel, which provides that God, completely righteous and without sin, by His infinite grace, justifies man who is by nature unrighteous and sinful. This cannot be accomplished by any work or merit by man to somehow achieve good standing with God, but instead is accomplished by and through the work of Jesus Christ's death on the cross. Thus, by faith alone in Christ alone, man is counted righteous by God.

This doctrinal requirement that a Christian must pursue all aspects of his or her life in obedience to Christ compels Christians to do more than give mere intellectual assent. The

Christian faith requires not only belief, but also conduct, and this requirement extends to every facet of the Christian's life. See *James* 2:17 ("So also faith by itself, if it does not have works, is dead."); *Romans* 12:1 (urging Christians, "in view of God's mercy," to devote their entire beings \*7 to Him as "true and proper worship"); see also *Korte v. Sebelius*, 735 F.3d 654, 681 (7th Cir. 2013) (noting religious belief is not confined to the home and the house of worship because "[r]eligious people do not practice their faith in that compartmentalized way."); The Baptist Faith & Message 2000, Article XV ("All Christians are under obligation to seek to make the will of Christ supreme in our own lives and in human society.... Every Christian should seek to bring industry, government, and society as a whole under the sway of the principles of righteousness, truth, and brotherly love."). Scripture and history are replete with instances in which Christian believers who were presented with a choice either to violate their consciences by complying with the state's demands or to face draconian penalties chose to maintain the integrity of their faith in every aspect of life and accept the consequences. See generally John Foxe, *Acts and Monuments* (1563) (recounting anecdotes of early Protestant martyrs). For example, the Old Testament Scripture recounts the story of three Hebrew men who refused to worship an image of Babylonian King Nebuchadnezzar, despite the threat of execution for noncompliance. *Daniel* 3:1-30. Shadrach, Meshach, and Abednego were cast "into the burning fiery furnace" for refusing to worship the king's image. *Id.* Although the Babylonian government conceived the requirement of bowing down to the image as merely an act of political loyalty, the three young men understood it as a requirement to violate their faith through idolatry. *Id.*

Similarly, the second-century Christian martyr Polycarp was willing to suffer death for refusing to state "Caesar is Lord." See Justo L. Gonzalez, *The \*8 Story of Christianity*, Vol. 1, 43-44 (1984). To the Roman government, the law was merely a political issue, but to Polycarp, it was an issue of idolatry. Likewise, the Protestant reformer Martin Luther, when asked to recant his beliefs, famously stated to Emperor Charles V, "[M]y conscience is captive to the Word of God. I cannot and I will not recant anything, since it is neither safe nor right to go against conscience. May God help me. Amen." Martin Luther, *Luther's Works*, Vol. 33: *Career of the Reformer III* (1972).

Baptist history in America abounds with examples of the doctrinal connection between faith and practice, even when that faith compelled action that ran contrary to the social mores of the day. For example, Roger Williams - founder of the first Baptist church in America - founded the only colony to prohibit slavery and tolerate religious

dissenters. See Aaron Schwabach, *Thomas Jefferson, Slavery, and Slaves*, 33 *T. Jefferson L. Rev.* 1, 14 n. 73 (2010) (noting that the colony of Rhode Island, under Williams' leadership, "prohibited slavery, tolerated Quakers and Jews, and endeavored to maintain peaceful relations with the Pequod Indians, who had been the victims of massacre and enslavement by the Massachusetts settlers"). Similarly, John Leland, a widely known Baptist minister in colonial Virginia, was a staunch abolitionist and a firm voice in support of religious liberty, free from government coercion and control:

"Does a man upon entering into social compact surrender his conscience to that society to be controlled by the laws thereof ...?" I judge not, for the following reasons:

\*9 1. Every man must give an account of himself to God, and therefore every man ought to be at liberty to serve God in that way that he can best reconcile it to his conscience. If government can answer for individuals at the day of judgment, let men be controlled by it in religious matters; otherwise let men be free.

In light of these Scriptural commands, Christian doctrine, and Baptist tradition, it is no surprise that the types of work done by Petitioners, *amici*, and related organizations - e.g., funding and organizing international missions, educating students and church members from a Christian perspective, and providing physical and spiritual care for orphans and widows - are, in fact, spiritual obligations that are ministerial and sacred in nature. See, e.g., *Matthew*. 25:37-40; *Matthew* 28:19; *James* 1:27; see also *The Baptist Faith and Message 2000* Art. XII ("An adequate system of Christian education is necessary to a complete spiritual program for Christ's people."); *The Baptist Faith and Message 2000* Art. XV ("We should work to provide for the orphaned, the needy, the abused, the aged, the helpless, and the sick."); SBC Resolution On Adoption and Orphan Care, 2009 \*10 ("[W]e encourage local churches to champion the evangelism of and ministry to orphans around the world."), available at <http://www.sbc.net/resolutions/1194> (last visited August 7, 2015). In light of that spiritual duty, it is not surprising that Petitioners refuse to quail before the government's demand to violate conscience or suffer government sanction.

In sum, because Christian doctrine requires that faith govern every aspect of a Christian's life and teaches that a Christian's conscience is captive to the word of God, Christians must act in accordance with their beliefs and in integrity of conscience in every aspect of life. Simply stated, the exercise of Christian faith must, as a matter of scriptural teaching, church tradition, and denominational doctrine, guide and determine a Christian's decisions, choices, words, and deeds, both in private and in every facet of life.

**II. Scripture and Southern Baptist doctrine teach that life begins at conception and therefore abortion is the taking of innocent human life and is a grave moral wrong.**

Southern Baptists have spoken clearly in opposition to abortion and in support of their belief that life begins at conception. These beliefs are grounded in the words of Scripture, which teach that God's knowledge of, care for, and sovereign plan for each person begins long before birth. See *Jeremiah* 1:4-5 ("Now the word of the Lord came to me, saying, 'Before I formed you in the womb I knew you, and before you were born I consecrated you; I appointed you a prophet to the nations.'"); *Psalms* 139:13-16 (noting that God "formed my inward parts ... knitted me together in my mother's womb," and knew "the days that were formed for me, when as yet <sup>11</sup> there was none of them"); *Luke* 1:39-44 (recounting that when Elizabeth, who was pregnant with John the Baptist, met Mary who would be the mother of Jesus, "the baby in [her] womb leaped for joy").

These and other Scriptural teachings can be distilled into four core principles undergirding the Baptist pro-life belief. First, God holds human life in high regard because "God created man in his own image." *Genesis* 1:27. Being made in the image of God stamps every human life with intrinsic worth and dignity. Second, Scripture teaches that a mother's womb contains a living human being created by God. Thus, abortion ends a human life. For example, in *Luke* 1:39-44, the inspired author of the Scripture describes the "baby" (Gr. βρ>εφοζ) in Mary's womb using the same word as is elsewhere used to describe an infant who has been born. The same scriptural passage affirms the personhood of the baby in the womb by ascribing to him the quintessentially human emotion of "joy." Third, God's word consistently condemns the killing of innocent human beings. See *Proverbs* 6:16-17 (declaring that God "hates ... hands that shed innocent blood."); *Psalms* 106 (describing how the "anger of the Lord was kindled" when his people "poured out innocent blood, the blood of their sons and daughters"). Finally, God calls his followers to "open your mouth for the mute, for the rights of all who are destitute," *Proverbs* 31:8, and, as there is "opportunity[,] ... do good to everyone," *Galatians* 6:10. No one is more mute or defenseless than the 1.2 million unborn slain annually in the United States through abortion.

In keeping with these Scriptural teachings, Southern Baptists stand firmly in support of the sanctity of human life, including the unborn. See The \*12 Baptist Faith and Message 2000 Art. XV (“We should speak on behalf of the unborn and contend for the sanctity of all human life from conception to natural death.”); *id.* at Art. XVIII (“Children, from the moment of conception, are a blessing and heritage from the Lord.”); SBC Resolution On Adoption and Orphan Care, 2009 (“Southern Baptists have articulated an unequivocal commitment to the sanctity of all human life, born and unborn.”); SBC Resolution On Thirty Years of *Roe v. Wade*, 2003 (“The Bible affirms that the unborn baby is a person bearing the image of God from the moment of conception.”); SBC Resolution on Sanctity of Human Life, 1991 (“Southern Baptists have historically affirmed biblical teaching regarding the sanctity of human life by adopting numerous pro-life resolutions at the national, state, and local levels.”); SBC Resolution On Encouraging Laws Regulating Abortion, 1989 (“Southern Baptists have historically upheld the sanctity and worth of all human life, both born and preborn, as being created in the image of God.”); SBC Resolution on Abortion, 1984 (noting an unborn child “is a living individual human being”).<sup>4</sup>

In accordance with these beliefs about unborn human life, Southern Baptists have a firm and well-known theological opposition to abortion, and the Southern Baptist Convention has repeatedly expressed its opposition to abortion in the strongest \*13 terms. See SBC Resolution On Adoption and Orphan Care, 2009 (“The satanic powers and the ravages of sin have warred against infants and children from Pharaoh to Molech to Herod and, now, through the horrors of a divorce culture, an abortion industry, and the global plagues of disease, starvation, and warfare.”); SBC Resolution On Planned Parenthood, 2008 (“Scripture speaks to the sanctity of human life in the womb[] and God's abhorrence of those who murder the innocent.”); SBC Resolution on Sanctity of Human Life, 1991 (“[W]e ... affirm the biblical prohibition against the taking of unborn human life except to save the life of the mother; and ... we call on all Southern Baptists to work for the adoption of pro-life legislation in their respective states which would expand protection for unborn babies.”); SBC Resolution On Encouraging Laws Regulating Abortion, 1989 (“[T]he messengers to the annual meetings of the Southern Baptist Convention during the past decade have repeatedly reaffirmed their opposition to legalized abortion, except in cases where the mother's life is immediately threatened ... [and] we do reaffirm our opposition to legalized abortion.”); SBC Resolution on Abortion, 1984 (characterizing abortion-on-demand as a “national sin”).<sup>5</sup>

In addition, Southern Baptists have expressly opposed the use of abortion-inducing drugs such as \*14 the so-called morning-after pill because such drugs kill an unborn human person. See SBC Resolution on RU 486, 1994 (“RU 486, the French abortion pill, is a direct assault on the sacredness and value of unborn human life in that this drug kills an unborn child whose heart has already started to beat.”); SBC Resolution on Sanctity of Human Life, 1991 (“[W]e oppose the testing, approval, distribution, and marketing in America of new drugs and technologies which will make the practice of abortion more convenient and more widespread.”).<sup>6</sup>

In keeping with these Baptist beliefs and historic Protestant beliefs,<sup>7</sup> prominent Southern Baptist theologians and ministers have and continue to decry the grave moral wrong of abortion. See R. Albert Mohler, Jr., *“I Feel Super Great About Having an Abortion” - The Culture of Death Goes Viral*, May 8, 2014; ERLC Letter to Congress on No Taxpayer Funding for Abortion Act, January 27, 2014; R. Albert Mohler, Jr., *So What if Abortion Ends a Life? Rare Candor from the Culture of Death*, February 1, \*15 2013; R. Albert Mohler, Jr., *“Abortion is as American as Apple Pie” - The Culture of Death Finds a Voice*, January 20, 2012;<sup>8</sup> Carl F.H. Henry, *Has Democracy Had Its Day?* at 28-29 (1996) (commending those “who resisted the federal government’s intrusion into the sphere of religious values, notably ... the public funding of abortion”); Carl F.H. Henry, *Twilight of a Great Civilization* at 34 (1988) (“[W]hen government engages in programs that violate Christian conscience, such as funding abortions, ... bold protest is proper.”).

These beliefs and obligations guide not only Southern Baptist ministers and individuals, but also instruct the policy and practice of all Southern Baptist ministries and entities. See SBC Resolution on Abortion, 1987 (“[W]e encourage all agencies and institutions of the SBC to use their resources and program ministries to promote the sanctity of human life.”), available at <http://www.sbc.net/resolutions/22/resolution-on-abortion> (last visited August 7, 2015).

In light of the clear Southern Baptist conviction on the sanctity of life and the moral wrong of abortion, it is no surprise that Southern Baptist entities like Petitioners refuse to provide abortion-inducing drugs either directly or indirectly by authorizing, obligating, or incentivizing their health care providers to do so using Petitioners' health plan information and infrastructure.

**\*16 III. Christian doctrine and Southern Baptist teaching state it is a sin for a Christian to enable or aid another in doing what the Christian believes to be wrong.**

As a result of the holistic scope of the Christian faith and the Southern Baptist theological opposition to abortion, the Petitioners, as a matter of doctrine and conscience, cannot distribute abortion-inducing drugs and devices either directly or indirectly by authorizing, obligating, or incentivizing their own third-party administrators to use Petitioners' health plans to provide such drugs and devices to others. Christian doctrine, like the civil and criminal law of this nation, teaches that one who knowingly aids or abets another's wrongdoing has himself done wrong. *See, e.g., Matthew 18:6* (“[W]hoever causes one of these little ones who believe in me to sin, it would be better for him to have a great millstone fastened around his neck and to be drowned in the depth of the sea.”); *Romans 14:13-14* (“Therefore let us not pass judgment on one another any longer, but rather decide never to put a stumbling block or hindrance in the way of a brother” and thus cause them to sin); *1 Corinthians 8:9-13* (warning Christians to take care not to be a “stumbling block” to others and noting that by “sinning against your brothers and wounding their conscience when it is weak, you sin against Christ”); *The Larger Catechism of the Westminster Assembly* 245 (1841) (“That what is forbidden or commanded to ourselves, we are bound, according to our places, to endeavour that it may be avoided or performed by others.”).

This principle applies with particular force to situations in which a Christian's action or inaction involves the taking of life. *See The Large Catechism* \*17 by Martin Luther (1529), reprinted in *Triglot Concordia: The Symbolical Books of the Ev. Lutheran Church* (1921) (“So also, if you see any one innocently sentenced to death or in like distress, and do not save him, although you know ways and means to do so, you have killed him.”); Thomas Vincent, *An Explanation of the Assembly's Shorter Catechism* 171-72 (1806) (“We are forbidden to kill ... others, either directly ... or indirectly, by doing any thing that tendeth thereunto.... We may be guilty of the murder of ... others, indirectly, by doing any thing that tendeth to take away ... others lives.”).

Congress and State legislatures have long recognized that one's sincere religious beliefs may prevent him from approving, authorizing, or aiding another in something the believer considers to be wrong, even if the believer is not himself committing the underlying wrong. For example, Congress exempts religious conscientious objectors not only from combat roles but from participation “in any form” in war. 50 U.S.C. App. § 456(j); *Hanna v. Secretary of the Army*, 513 F.3d 4 (1st Cir. 2008) (upholding permanent injunction exempting Coptic Christian physician from active duty because she could not perform her chosen profession in the military context without violating her deeply held religious

beliefs). Also, physicians and hospitals with a religious objection to abortion are exempt not only from performing abortion but also from assisting, making their facilities available, or even making referrals for abortion. 42 U.S.C. § 300a-7; 42 U.S.C. § 238n. Similarly, “eleven states and the federal government have adopted some type of statute or regulation to ensure that individuals are not forced to participate in executions against their will.” Mark **\*18** L. Rienzi, *The Constitutional Right Not to Kill*, 62 Emory L.J. 121, 139 (2012). The courts, like the legislatures, recognize that one's religious beliefs may prevent believers from any attenuated authorization or complicity in conduct they consider to be wrong. See, e.g., *Hobby Lobby Stores, Inc. v. Sebelius*, 723 F.3d 1114, 1142 (10th Cir. 2013), *aff'd sub nom. Burwell v. Hobby Lobby Stores, Inc.*, 134 S. Ct. 2751 (2014) (“And the question here is not whether the reasonable observer would consider the plaintiffs complicit in an immoral act, but rather how the plaintiffs themselves measure their degree of complicity.”); *Gilardi v. U.S. Dept. of Health and Human Services*, 733 F.3d 1208, 1215 (D.C. Cir. 2013), *vacated on other grounds*, 134 S. Ct. 2902 (2014) (noting that “even attenuated participation may be construed as a sin”); *Thomas v. Anchorage Human Rights Comm'n*, 165 F.3d 692 (9th Cir. 1999), *vacated on other grounds*, 220 F.3d 1134 (9th Cir. 2000) (*en banc*) (recognizing a Christian landlord's sincere religious belief that unmarried cohabitation was sin merited exemption from state and local housing laws); *State by Cooper v. French*, 460 N.W.2d 2, 7 (Minn. 1990) (same, under Minnesota Constitution). Indeed, courts have previously recognized this concept in this very context. *Hobby Lobby*, 723 F.3d at 1140 n.15 (“The assertion that life begins at conception is familiar in modern religious discourse .... Moral culpability for enabling a third party's supposedly immoral act is likewise familiar.”).

The statutory and judicial religious exemptions enumerated above are notable for several reasons. First, none of them make the applicability of the exemption dependent on whether the religiously **\*19** motivated conduct involves “sacred” or seemingly “secular” conduct. See *Attorney Gen. v. Desilets*, 636 N.E.2d 233, 238 (Mass. 1994) (“The fact that the defendants' free exercise of religion claim arises in a commercial context ... does not mean that their constitutional rights are not substantially burdened.”). Second, they recognize that religious belief not only prevents believers from engaging directly in sin but also prevent *any* participation, authorization, or enabling of what they consider to be sin. See *Rienzi*, 62 Emory L.J. at 139 (noting the statutory exemptions from participating in capital punishment “protect the individual not only from direct involvement - such as personally administering a lethal injection or turning on the electric chair - but also less

direct involvement such as preparing the individual and apparatus used, supervising other people who will do these things, or even attending the execution.”). Finally, many of these exemptions involve situations involving the taking of human life, recognizing that to compel individuals to participate in what they believe to be an unjustified taking of life imposes a grievous burden on the exercise of their beliefs.

Here, like in the foregoing examples, the Petitioners' refusal to be complicit in wrongdoing is in no way undercut by the fact that Southern Baptists, like other Christians over the past two millennia, pay taxes that may ultimately be used to fund objectionable acts. The payment of taxes is distinguishable in several ways. First, Jesus expressly commanded his followers to do so - a command given to hearers who would have found many of Caesar's activities to be objectionable - while simultaneously recognizing that payment of taxes <sup>\*20</sup> did not forfeit a believer's primary obligations to follow God's commands. See *Mark 12:17* (“Jesus said to them, ‘Render to Caesar the things that are Caesar's, and to God the things that are God's.’”). Second, the act of paying a tax does not itself require one citizen to intentionally, directly, and personally obligate, authorize, incentivize, or materially assist another citizen to engage in known objectionable conduct. In contrast, the HHS mandate forces the Petitioners to sign and deliver a form with the purpose of expressly authorizing or incentivizing the use of Petitioners' own health plan information and infrastructure to provide abortion-inducing drugs; drugs whose sole purpose and use is inherently morally objectionable and which otherwise would not be provided. Third, the vast majority of each tax dollar paid by Petitioners is spent on things that they do not find inherently morally objectionable, a fact that comports with the Scriptural recognition that a proper function of the state is to do good and punish evil. See *Romans 13:3-7*. Here, in contrast, the certain effect of participating in the mandate scheme is to authorize, obligate, or incentivize Petitioners' third-party administrators to engage in specific conduct Petitioners find morally objectionable, and in a way that requires Petitioners' ongoing support and assistance (by maintaining and regularly updating the health plan information and infrastructure).

In analogous contexts, courts have implicitly recognized a distinction between complicity in wrongdoing and the mere payment of taxes. For example, the Supreme Court has recognized that a pacifist has a legitimate moral objection to being forced to work in a factory making war goods. See <sup>\*21</sup> *Thomas v. Review Bd. of Indiana Employment Sec. Div.*, 450 U.S. 707 (1981). The fact that Thomas also paid taxes that were used to

support the war effort did not scuttle his argument that manufacturing weapons made him complicit in the war and thus violated his religious beliefs.

In sum, scriptural teaching and Southern Baptist doctrine state it is a sin for a Christian to enable or aid another in doing what the Christian believes to be wrong. As a matter of doctrine and conscience, Petitioners cannot comply with the government's mandate to delegate to another the repugnant task of distributing abortion-inducing drugs and devices.

**IV. Requiring Christians to choose between violating the Government's regulations or violating their sincerely held religious beliefs substantially burdens their exercise of religion.**

The Religious Freedom Restoration Act of 1993 ("RFRA"), 42 U.S.C. §§ 2000bb *et seq.*, prohibits the federal government from substantially burdening "a person's exercise of religion," *id.* at § 2000bb-1(a), unless applying that burden is the "least restrictive means of furthering ... [a] compelling governmental interest," *id.* at § 2000bb-1(b). In enacting RFRA, Congress sought to restore the compelling interest test for defenses to claims that a facially neutral law of general applicability "substantially burdens" the free exercise of religion - a test that had been abandoned by the Supreme Court in *Employment Division, Department of Human Resources v. Smith*, 494 U.S. 872 (1990). See 42 U.S.C. § 2000bb(b)(1) ("The purposes of this chapter are: (1) to restore the compelling interest test as set forth in *Sherbert v. Verner*, 374 U.S. 398 (1963) and \*22 *Wisconsin v. Yoder*, 406 U.S. 205 (1972) and to guarantee its application in all cases where free exercise of religion is *substantially burdened.*") (emphasis added). Thus, RFRA creates a statutory right to exemption from laws that substantially burden sincere religious beliefs, even if the law is neutral and generally applicable, unless the government can prove that "strict scrutiny" is met. *O'Bryan v. Bureau of Prisons*, 349 F.3d 399, 401 (7th Cir. 2003).

The existence of a substantial burden is most apparent when the government forces a person or group to "perform acts undeniably at odds with fundamental tenets of their religious beliefs." *Wisconsin v. Yoder*, 406 U.S. 205, 218 (1972) (finding that compulsory formal secondary education was an undue burden on the free exercise of Amish parents' religion). Further, a substantial burden can arise indirectly if the receipt of benefits is conditioned on the performance of conduct proscribed by a religious faith, or benefits are denied because of conduct required by a religious faith. *Thomas*, 450 U.S. at 717-18 (determining that a denial of unemployment benefits to an employee who had a religious objection to war was a burden on his religion).

As a threshold matter, the religious objection or conduct at issue must be both sincere and religious. *Hobby Lobby*, 723 F.3d at 1140. The religious belief is not, however, required to be central to the person's faith, 42 U.S.C. § 2000cc-5(7)(A), nor is it required to be a "correct" interpretation. See *United States v. Lee*, 455 U.S. 252, 257 (1982) ("Courts are not arbiters of scriptural interpretation."); *id.* at 261 n.12 (courts cannot "speculate whether" the peculiarities of a legal scheme "ease or mitigate the perceived sin of participation") (quoting *Thomas*, 450 U.S. at 716)).

\*23 Instead, a party must only show an "honest conviction" that the pressure from the government substantially conflicts with his religion. *Thomas*, 450 U.S. at 716. Rather than questioning the validity of the belief, the court undertaking the substantial burden analysis under RFRA should focus on the intensity of the coercion applied by the government, requiring that the restrictive law protect "interests of the highest order." *Church of the Lukumi Babalu Aye, Inc. v. City of Hialeah*, 508 U.S. 520, 546 (1993). Christian doctrine requires Christian individuals and entities to consistently conduct themselves in accordance with their beliefs. See Part I, *supra*. Furthermore, Christians should not be required to abandon the task to which they have been called by God solely because of governmental intrusion and penalties. See *The Baptist Faith & Message 2000*, Art. XVII ("Civil government being ordained by God, it is the duty of Christians to render loyal obedience thereto in all things not contrary to the revealed will of God.... The state has no right to impose penalties for religious opinions of any kind."), available at <http://www.sbc.net/bfm2000/bfm2000.asp> (last visited August 7, 2015). Forcing Southern Baptist entities like Petitioners to choose between paying crippling fines by conducting their ministries in accord with their religious tenets or sacrificing those core values in order to preserve the ministry is exactly the type of coercion the substantial burden test encompasses.

The Supreme Court has previously recognized that sincerely-held religious beliefs subject to government pressure at the workplace can result in a substantial burden on religion. *Thomas*, 450 U.S. at 716 (finding a substantial burden where an employee with a religious belief against producing war \*24 materials was denied unemployment benefits after quitting when transferred to a factory producing tank turrets); *Sherbert*, 374 U.S. at 404 (holding the denial of unemployment benefits placed a substantial burden on a Seventh-Day Adventist who quit her job after being forced to work on Saturday). Significantly, the government has recognized this substantial burden by establishing exemptions for other religious groups cornered into making this choice. See 45 C.F.R. §

147.131 (2013) (allowing HRSA to exempt religious employers from requirement to cover contraceptive services under group health plan); *see also* 78 Fed. Reg. 39870 (July 2, 2013) (“[G]roup health plans established or maintained by certain religious employers (and group health insurance coverage provided in connection with such plans) are exempt from the otherwise applicable requirement to cover certain contraceptive services”). The discrimination involved in the Government's exemption of *some* groups only compounds the burdensome nature of the fines imposed on non-exempt groups that share the same religious views. <sup>¶</sup> *Sherbert*, 374 U.S. at 406 (noting a prohibition against requiring employees to work on Sunday compounds the unconstitutionality of forcing a Sabbatarian to work on Saturday).

In sum, the government's mandate substantially burdens the religious exercise of Petitioners' Christian ministries by imposing draconian fines for acts specifically mandated by Christian doctrine.

#### **\*25 Conclusion**

For the foregoing reasons, *amici* respectfully request this Court grant the petition for a writ of certiorari and set the case for plenary review of whether centuries-old religious groups may practice their historic beliefs free from intrusive regulation.

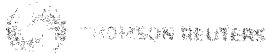
