## CONSENT APPLICATION FOR SEVEN-DAY EXTENSION OF TIME TO FILE REPLY BRIEF ON THE MERITS

## To the Honorable Clarence Thomas, Circuit Justice for the Eleventh Circuit:

Under this Court's Rule 30.3, petitioner Karyn D. Stanley respectfully requests an extension of time to and including December 18, 2024, to file her reply brief on the merits. Respondent consents to this request as described in its letter to this Court of October 22, 2024, which requests a fourteen-day extension of the time to file respondent's merits brief.

Respondent's merits brief is currently due on October 28. On October 22, respondent's requested that the Court set the following briefing schedule:

Brief for the respondent: November 11, 2024 Reply brief for the petitioner: December 18, 2024

The parties agree that this schedule is appropriate. In light of respondent's unexpected fourteen-day extension request, which is justified by the recent hurricane in Florida, petitioner seeks a seven-day extension of time for her reply. Assuming that respondents'

proposed extension is granted, the reply would be due on December 11. Good cause for a one-week extension of that deadline (through December 18) exists because petitioner's counsel has several intervening obligations, including an oral argument in this Court on November 13 and an oral argument in the Nevada Supreme Court on December 4, and multiple competing briefing deadlines, that would make it difficult for him and his colleagues to prepare the reply absent a one-week extension.

Oral argument in this case has not yet been set. The proposed schedule will allow this case to be heard in the Court's January sitting, which begins on January 13, 2025.

For the foregoing reasons, petitioner respectfully requests that the time for filing her reply brief on the merits in this case be extended to and including December 18, 2024.
