I am submitting this letter to request a 60-day extension of time from 11/13/23 to 1/12/24 to file my pending petition for a writ of certiorari about the order that was issued on 8/15/23 by the U.S. Court of Appeals for the Second Circuit (“the Second Circuit”) in *Komatsu v. Urban Pathways, Inc.*, No. 23-654 (2d Cir. Aug. 15, 2023) that is hereinafter referred to as “K1. There will be no prejudice to the opposing party nor its attorneys if this request for an extension is granted. I seek to be represented by counsel for this appeal and am also involved in related litigation that may soon enable me to obtain critically important discovery material that will likely prove to be very beneficial for this appeal. I need the extension of time for this appeal both to try to obtain counsel for this appeal and get the discovery material that I seek.
