Dear Mr. Harris:

I write to notify the Court of a development regarding the Louisiana Secretary of State's Motion "for Enlargement and Division of Time for Oral Argument" filed today. The Motion accurately reflects (at 2) the State's opposition as relayed to the Secretary on September 15. On September 19, the Attorney General of Louisiana—as "the chief legal officer of the state," La. Const. art. IV, § 8—exercised her authority over state agencies and ministerial officials like the Secretary of State to disapprove the Secretary's outside-counsel contracts in all litigation matters. *See* La. R.S. §§ 49:257(E), 49:258. Accordingly, the Attorney General will assume representation of the Secretary in all pending matters. A copy of the Attorney General's disapproval letter is attached.

Consistent with the Secretary's representation to this Court, the State of Louisiana, through the Attorney General, will remain the State's sole representative in this Court in this litigation. *See* Rule 18.2 Letter (Aug. 1, 2024) ("Pursuant to Supreme Court Rule 18.2, Applicant Nancy Landry, in her official capacity as Secretary of State of Louisiana, by and through undersigned counsel, hereby gives notice that she has no interest in the outcome of the appeal in the above-captioned matter.").
