I represent Respondents in the above-captioned matter. A brief in opposition is currently due on September 16, 2024. I respectfully request, under Rule 30.4 of the rules of this Court, that the time to file a response be extended by 30 days, to and including October 16, 2024. Petitioners consent to this request.

An extension is warranted because I have prior deadlines in other courts between now and the end of September.
